CHAPTER 40

Appropriation Act No. 4, 1992-93

[Assented to 23 June 1992]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$347 000 000
for 1992-93

1. The Government may take out of the consolidated revenue fund a sum not exceeding \$347 000 000 to defray a part of the expenses of Québec proposed in the supplementary estimates for the fiscal year 1992-93 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule to this Act.
