## CHAPTER 77

### **An Act respecting Les cimetières catholiques romains de l'archidiocèse de Gatineau-Hull**

*[Assented to 14 May 1992]*

**Preamble** WHEREAS cemeteries situated in the archdiocese of Gatineau-Hull are presently held and administered by the Roman Catholic Archbishop of the diocese;

Whereas it is expedient that such cemeteries be administered by a separate and distinct corporation;

Whereas it is expedient that such corporation have the powers necessary for the pursuit of its objects;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**Establishment** 1. A corporation is hereby established under the name: "Les cimetières catholiques romains de l'archidiocèse de Gatineau-Hull".

**Corporate seat** 2. The corporate seat of the corporation is situated at Gatineau.

**Objects** 3. The objects of the corporation are the holding and administration of Roman Catholic cemeteries situated in the archdiocese of Gatineau-Hull. The corporation may also provide any form of funeral services including interment, disinterment, cremation, burial, thanatopraxy and any method of disposal recognized by the rites and customs of the Roman Catholic Church.

**Powers** 4. The corporation is a corporation within the meaning of the Civil Code, and is vested with the general powers of such a corporation and the special powers conferred upon it by this Act.

**Non-profit purposes**      The corporation is constituted exclusively for non-profit purposes and, as such, no revenue in the form of a dividend or otherwise, is payable to any member or is otherwise made available for the personal benefit of any member and, upon the winding-up or dissolution of the corporation, all its property and capitalized revenue must be transferred to an organization which has similar objectives and fulfills the conditions required to be exempt from income tax.

**Governing provisions**      **5.** Subject to this Act, the corporation is governed by Divisions V, VI, VII and VIII of the Act respecting Roman Catholic cemetery corporations (R.S.Q., chapter C-69).

**Visitor**      **6.** In addition to the powers conferred upon him by the Act respecting Roman Catholic cemetery corporations, the Archbishop of the archdiocese of Gatineau-Hull is also deemed to be the visitor of the corporation.

**Board of directors**      **7.** The corporation is administered by a board of directors composed of not less than seven persons appointed by the Archbishop, the exact number being determined by the latter.

**Dismissal**      **8.** The Archbishop may, at any time and without giving reasons, dismiss any director from office.

Keeping of

“When such authorization is granted, it shall be for the Archbishop to designate the clergyman or any other person for keeping such registers.

Powers

Any person other than a clergyman who is designated for keeping the registers is, in that respect, vested with the same powers as a clergyman and the acts of burial he receives are authentic.”

“**46.** The corporation may transfer the whole of its property with the obligation of paying its liabilities, to a corporation constituted under this Act, to the Archbishop or to a corporation he designates.”

**19.** Section 48 of the said Act is amended for the corporation

(1) by repealing subparagraph *c* of the first paragraph;

(2) by replacing the words “delegate of a member” in subparagraph *d* of the first paragraph by the words “member of the board of directors”.

**20.** For the purposes of the Act respecting Roman Catholic cemetery corporations, the words “bishop of the place” mean the Archbishop of the archdiocese of Gatineau-Hull.

Applicable  
by-laws

**21.** Until the adoption by the corporation of by-laws concerning the management and administration of cemeteries and other property that may have been transferred to it by the Archbishop or any other parochial body, the by-laws adopted by the Roman Catholic

Archbishop of Gatineau-Hull shall continue to apply to the corporation.

Letters  
patent

**22.** For the purposes of the Act respecting Roman Catholic cemetery corporations, this Act constitutes the letters patent of the corporation.

Coming into  
force

**23.** This Act comes into force on 14 May 1992.
