THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$19 240

for 1990-91

**1.** The Government may take out of the consolidated revenue fund a sum not exceeding \$19 240 206 725.00 to defray a part of the expenses of Québec proposed in the estimates for the fiscal year 1990-91 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule, less the amounts voted under the Appropriation Act No. 1, 1990-91 (\$7 238 416 975.00).
