CHAPTER 21

Appropriation Act No. 3, 1989-90

[Assented to 19 June 1989]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$237 438 000
for 1989-90

1. The Government may take out of the consolidated revenue fund a sum not exceeding \$237 438 000 to defray a part of the expenses of Québec proposed in the supplementary estimates for the fiscal year 1989-90 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule to this Act.

2. This Act comes into force on 19 June 1989.
