NOTE

This volume contains the text of every Act assented to in 1988.

It also contains various information to assist the reader in locating specific Acts or the stages leading to their adoption by the National Assembly in finding out certain incidence on existing legislation.

Each Act is preceded by an introductory page which contains, in addition to the chapter number and title of the Act, the number it had as a bill, the name of the Member who introduced the bill, the date of each stage leading to its adoption by the National Assembly, the date of assent and the date or dates of coming into force, so far as known on 1 March 1989, and a listing of the Acts that are amended by that Act.

The table of amendments contains a cumulative listing of the amendments made to the Revised Statutes of Québec, 1977 and to other public Acts, including the amendments made by the Acts of 1988. This is followed by a table of general amendments made from 1981 and a table of the corrections made from 1979 for updating purposes in accordance with the Act respecting the consolidation of the statutes and regulations (R.S.Q., chapter R-3).

The equivalence table lists the chapter number assigned to the Acts adopted between the updatings of 1 January 1988 and 1 January 1989 in the Revised Statutes of Québec.

The table of proclamations lists the dates on which Acts or parts of Acts have come into force by proclamation or order since 1964 except those already indicated in the annual volume of statutes, and is followed by a table listing the provisions which have not yet been brought into force by proclamation or order. As prescribed by law, other tables list the letters patent issued in 1988 in respect of certain municipal corporations.

The concordance table establishes the correspondance between the number assigned to each bill before it is assented to and its chapter number in the annual volume of statutes.

Except the index which is found at the end of the volume, most of the information described above is found in that part of the annual volume referred to as the yellow pages.
