## CHAPTER 83

### **An Act respecting the pension plan of the non-teaching staff of the Commission des écoles catholiques de Montréal**

*[Assented to 23 December 1988]*

**Preamble** WHEREAS a pension plan for the non-teaching staff was established by the Commission des écoles catholiques de Montréal;

Whereas the administration of the pension plan was entrusted to a pension committee of the Commission des écoles catholiques de Montréal;

Whereas the council of commissioners of the Commission des écoles catholiques de Montréal, at the regular sitting of 14 May 1986, passed resolution XXXIV whereby it gave its approval to a pension adjustment formula;

Whereas section 125 of the Act respecting the Government and Public Employees Retirement Plan (R.S.Q., chapter R-10) provides that no supplementary pension plan may be amended except with the prior approval of the Commission administrative des régimes de retraite et d'assurances and that any additional costs resulting from an amendment will be borne by the employees;

Whereas it is expedient to allow the Commission des écoles catholiques de Montréal to amend the pension plan of the non-teaching staff of the Commission des écoles catholiques de Montréal for the purpose of adjusting the pension of certain pensioners out of a portion of the actuarial surplus of the plan;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**Amendment** **1.** Notwithstanding section 125 of the Act respecting the Government and Public Employees Retirement Plan (R.S.Q., chapter R-10) and subject to the Act respecting supplemental pension plans (R.S.Q., chapter R-17), the pension plan of the non-teaching staff of

the Commission des écoles catholiques de Montréal may be amended, without increasing the employees contributions, for the purpose of adjusting the pension of certain pensioners out of a portion of the actuarial surplus of the plan.

**2.** The pension adjustment shall consist in increasing the annual pension already received by a pensioner under the pension plan of the non-teaching staff of the Commission des écoles catholiques de Montréal as of 30 June 1984 by the following amount, namely:

- (a) \$100 to each pensioner of 1984 or \$50 to eligible survivors;
- (b) \$200 to each pensioner of 1983 or \$100 to eligible survivors;
- (c) \$300 to each pensioner of 1982 or \$150 to eligible survivors;
- (d) \$400 to each pensioner of 1981 or \$200 to eligible survivors;
- (e) \$500 to each pensioner of 1980 or \$250 to eligible survivors;
- (f) \$600 to each pensioner of 1979 and preceding years or \$300 to eligible survivors.

**3.** The persons who are entitled to a pension adjustment under section 2 are those whose names appear on the list of pensioners used for compiling the data of the actuarial valuation of the plan made on 30 June 1984.

**4.** This Act comes into force on 23 December 1988.
