CHAPTER 9

An Act respecting expenditures made and not accounted for as at 31 March 1986

[Assented to 26 March 1987]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

Expenditu-
res as at 31
March 1986

1. The expenditures made and not accounted for as at 31 March 1986 in the amount of \$1 310 314 900 as shown in Schedules 1 and 2 are added to the net debt of the Government, as defined in the public accounts prepared pursuant to the Financial Administration Act (R.S.Q., chapter A-6) for the fiscal year ending on 31 March 1986.

Sums
required

2. The sums required for the payment of the expenditures contemplated in Schedule 1 shall be taken out of the consolidated revenue fund, and payment shall be effected at the time and according to the terms and conditions approved by the Minister of Finance.

Coming into
force

3. This Act comes into force on 26 March 1987.
