## CHAPTER 13

### Appropriation Act No. 2, 1987-88

*[Assented to 31 March 1987]*

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** The Government may take out of the consolidated revenue fund a sum not exceeding \$5 591 347 024.99 to defray a part of the expenses of Québec proposed in the estimates for the fiscal year 1987-88 as laid before the National Assembly, not otherwise provided for.

Apportion-  
ment

That sum is apportioned as follows:

(1) \$5 066 516 875.00, being one-fourth of the appropriations to be voted for each of the programs appearing in the estimates of expenses of the Government for the said fiscal year, except Program 6, "Social Aid Benefits", of the Ministère de la Main-d'oeuvre et de la Sécurité du revenu;

(2) \$67 759 500.00, being an additional one-fourth of the appropriations to be voted for Program 3, "Real Estate Assessment", of the Ministère des Affaires municipales;

(3) \$13 204 083.33, being an additional two-twelfths of the appropriations to be voted for Program 2, "Farm Financing", of the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation;

(4) \$3 416 900.00, being an additional four-twelfths of the appropriations to be voted for Program 2, "Promotion of Socio-cultural Recreational Activities", of the Ministère du Loisir, de la Chasse et de la Pêche;

(5) \$2 035 866.66, being an additional two-twelfths of the appropriations to be voted for Program 4, "Promotion of Physical and Sports Activities", of the Ministère du Loisir, de la Chasse et de la Pêche;

(6) \$358 688 600.00, being an additional two-twelfths of the appropriations to be voted for Program 6, "Social Aid Benefits", of the Ministère de la Main-d'oeuvre et de la Sécurité du revenu;

(7) \$79 725 200.00, being an additional one-fourth of the appropriations to be voted for Program 6, "School Transportation", of the Ministère des Transports.

**2.** This Act comes into force on 31 March 1987.
