## CHAPTER 92

### An Act to again amend the Courts of Justice Act

*[Assented to 18 December 1987]*

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

c. T-16,  
s. 8.1,  
added

**1.** The Courts of Justice Act (R.S.Q., chapter T-16) is amended by adding, after section 8, the following section:

**“8.1** For the purposes of section 22 of the Judges Act (R.S.C. 1970, chapter J-1), a judge of the Court of Appeal may, in his quality as a judge of that court and with the authorization of the chief justice, take part in an event connected with the administration of justice.”

**2.** The said Act is amended by adding, after section 31, the following section:

**“31.1** For the purposes of section 22 of the Judges Act, a judge of the Superior Court may, in his quality as a judge of that court and with the authorization of the chief justice, take part in an event connected with the administration of justice.”

**3.** Section 45 of the said Act is amended by adding, at the end of the first paragraph, the words “and, also, over that part of the municipality of Duhamel situated in the township of Gagnon”.

**4.** Section 79 of the said Act is amended by replacing the figure “73” in the first line of the second paragraph by the figure “74”.

**5.** Section 110 of the said Act is amended by replacing the expression “forty-three” at the end of the second paragraph by the figure “47”.
