## CHAPTER 125

### An Act respecting the town of Rock Forest

*[Assented to 18 December 1987]*

**Preamble** WHEREAS it is expedient to validate the imposition and levy by the town of Rock Forest of a compensation used to repay loans contracted under certain by-laws;

Whereas certain by-laws passed by the council of the corporation of Rock Forest before its erection as a town have not been published according to law;

Whereas it is in the interest of the town of Rock Forest to remedy this situation;

#### THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**Validity of  
compensa-  
tion**

**1.** The compensation imposed by the corporation of Rock Forest before its erection as a town and levied by the corporation and by the town of Rock Forest for the fiscal years 1967 to 1988 to provide for the payment of interest on and repayment of the principal of loans contracted under the by-laws mentioned in a schedule to this Act is hereby declared valid.

**By-laws  
deemed in  
force**

**2.** The by-laws passed before 1 January 1982 by the council of the corporation of Rock Forest before its erection as a town and which have not been published according to law are deemed to be in effect and to have force of law from the date on which they were passed or, as the case may be, from the date of their final approval where they were subject to one or more approvals.

**Publication**      No irregularity or illegality may be ascribed to the fact that the by-laws have not been published according to law.

**Reference**        **3.** The clerk shall enter a reference to this Act in the book of the by-laws of the town, opposite every by-law referred to in sections 1 and 2.

**Pending cases**    **4.** Sections 1 and 2 do not affect a case pending, a decision or a judgment made or rendered on or before 11 May 1987.

**Coming into force**   **5.** This Act comes into force on 18 December 1987.
