## CHAPTER 94

### Appropriation Act No. 5, 1986-87

*[Assented to 18 December 1986]*

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$70 457

**1.** The Government may take out of the consolidated revenue fund a sum not exceeding \$70 457 100 to defray a part of the expenses of Québec proposed in the supplementary estimates for the fiscal year 1986-87 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule to this Act.
