CHAPTER 35

Appropriation Act No. 4, 1983-84

[Assented to 22 June 1983]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$14 102
440 525
for 1983-84

1. The Government may take out of the consolidated revenue fund a sum not exceeding \$14 102 440 525 to defray part of the expenses of Québec proposed in the estimates for the fiscal year 1983-84 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule, less the amounts voted under the Appropriation Act No. 1, 1983-84 (\$152 642 500) and under the Appropriation Act No. 2, 1983-84 (\$4 966 181 575).
