CHAPTER 64

An Act respecting the city of Saint-Laurent

[Assented to 22 June 1983]

Preamble WHEREAS it is in the interest of the city of Saint-Laurent that certain powers be granted to it;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

Acquisition authorized **1.** The city of Saint-Laurent is authorized to acquire, in accordance with section 3 of the Industrial Funds Act (R.S.Q., chapter F-4), the immovable described in the schedule and the buildings thereon erected.

Presumption **2.** The immovable acquired under section 1 is deemed to have been acquired pursuant to the Industrial Funds Act.

Exception **3.** This Act shall operate notwithstanding the provisions of sections 2 and 7 to 15 of the Constitution Act, 1982 (Schedule B of the Canada Act, chapter 11 in the 1982 volume of the Acts of the Parliament of the United Kingdom).

Coming into force **4.** This Act comes into force on the day of its sanction.

SCHEDULE

A parcel of land, of irregular shape, known and designated as being part of lot 239 of the cadastre of the Parish of Saint-Laurent, registration division of Montréal and bounded as follows:

Bounded on the northeast by lots 240-1-76 to 240-1-89 and by part of lot 240-1-74, on the southeast by part of lot 239 (Côte Vertu Road expropriated), on the southwest by part of lot 2640, on the northwest by lots 239-8-4 to 239-8-7; measuring along the northeast line, five hundred and ninety-two feet and seventy-three hundredths (592.73 ft) or one hundred and eighty metres and sixty-six hundredths (180,66 m), along the southeast line, two hundred and ninety-two feet and twenty-seven hundredths (292.27 ft) or eighty-nine metres and eight hundredths (89,08 m), along the southwest line, five hundred and ninety-six feet and seventy-five hundredths (596.75 ft) or one hundred and eighty-one metres and eighty-eight hundredths (181,88 m), along the northwest line, two hundred and eighty-nine feet (289.0 ft) or eighty-eight metres and eight hundredths (88,08 m); having an area of one hundred and seventy-two thousand eight hundred and eighty one and seven-tenths square feet (172 881.7 sq. ft.) or sixteen thousand and sixty and seven-tenths square metres (16 060,7 square metres).

The lengths and area are in English measure and in the International System of Units (SI).
