CHAPTER 67

An Act respecting the city of La Baie

[Assented to 22 December 1983]

Preamble WHEREAS it is in the interest of the city of La Baie that certain powers be granted to it retroactively, allowing it to acquire or lease for sports and recreational purposes, immovables situated in the territory of the municipality of Saint-Félix-d'Otis;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

c. C-19, s. 28, am. for the city **1.** Section 28 of the Cities and Towns Act (R.S.Q., chapter C-19) is amended for the city of La Baie by inserting, after subsection 2, the following subsection:

Leasing or acquisition of immovables “(2.1) The corporation may, itself or through a non-profit corporation, provide for the acquisition by agreement or the leasing of immovables situated in the territory of the municipality of Saint-Félix-d'Otis and described in the schedule, for the purposes of organizing and operating a recreation centre and a public place for sports and amusements.”

Effect **2.** Section 1 has effect from 1 October 1969.

Exception **3.** This Act shall operate notwithstanding the provisions of sections 2 and 7 to 15 of the Constitution Act, 1982 (Schedule B of the Canada Act, chapter 11 in the 1982 volume of the Acts of the Parliament of the United Kingdom).

Coming into force **4.** This Act comes into force on the day of its sanction.

SCHEDULE

A territory situated in the township of Otis and comprising, with reference to the cadastre of the said township, part of lots 20, 21 and 22 of range V, and their present and future subdivisions, the whole included within the limits hereinafter described, to wit: starting from the point of intersection between the southwest shore of lake Otis and the northwest line of lot 20-A of range V; thence, successively, the following lines and demarcations: in range V, the northwest and southwest lines of the said lot 20-A; part of the dividing line between lots 20 and 21 for a distance of 12.58 chains, that is 253.07 metres; a straight line across lot 21 to a point on the southeast line of the said lot 21, at a distance of 6.42 chains, that is 129.15 metres from the dividing line between lots 21 and 21-A, such distance measured along the said southeast line; part of the said southeast line, southwesterly, to the northeast side of road number 170; the northeast side of the said road, southeasterly, to the southeast line of lot 22 of range V; the said southeast line to its last intersection with the southwest shore of lake Otis; finally, the southwest shore of the said lake in a generally northwesterly direction, to the starting point.
