## CHAPTER 78

An Act respecting Les Ressources Campbell Inc.,  
Les Ressources Camchib Inc. and Mines d'Amiante United Inc.

*[Assented to 7 June 1983]*

Preamble

WHEREAS Les Ressources Campbell Inc., having its head office at Chibougamau in the Province of Québec, is a company continued under Part IA of the Companies Act (R.S.Q., chapter C-38), as attested by the certificate of continuance dated 30 December 1981, such company having been incorporated under the Mining Companies Act (R.S.Q., chapter C-47) by letters patent dated 10 March 1950, amended by supplementary letters patent dated 7 October 1953, 14 November 1957, 28 March 1975, 3 September 1980 and 30 December 1981;

Whereas Les Ressources Camchib Inc., having its head office at Chibougamau in the Province of Québec, is a company resulting from the amalgamation, under Part IA of the Companies Act, of Les Ressources Camchib Inc. and Les Mines CCH (Québec) Inc., as attested by the certificate of amalgamation dated 14 March 1981, and the certificates of amendment dated 9 November 1982 and 24 March 1983, Les Mines CCH (Québec) Inc. having been incorporated under Part IA of the Companies Act, as attested by a certificate of incorporation dated 2 February 1981, Les Ressources Camchib Inc. having been incorporated under the Mining Companies Act by letters patent dated 27 November 1953, amended by supplementary letters patent dated 10 November 1954 and 30 October 1980;

Whereas Mines d'Amiante United Inc., having its head office at Montréal in the Province of Québec, is a company continued under Part IA of the Companies Act, as attested by a certificate of continuance dated 6 May 1982, such company being the result of the amalgamation by letters patent of amalgamation, dated 28 June 1973, of United Asbestos Corporation Limited (No Personal Liability), a company incorporated under the Mining Companies Act by letters patent dated 12 February 1948, amended by supplementary letters patent dated 21 December 1950 and 24 May 1966, and Allied Mining Corporation

(No Personal Liability), a company incorporated under the Mining Companies Act by letters patent dated 12 January 1950, amended by supplementary letters patent dated 21 March 1955, 23 March 1956 and 27 August 1969;

Whereas it is in the interest of Les Ressources Campbell Inc., Les Ressources Camchib Inc. and Mines d'Amiante United Inc. that their corporate status be confirmed;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

- Continuance      **1.** Les Ressources Campbell Inc. is validly continued under Part IA of the Companies Act (R.S.Q., chapter C-38) from 30 December 1981, namely the date shown in its certificate of continuance, the validity of which certificate is hereby confirmed.
- Amalgamation      **2.** Les Ressources Camchib Inc. and Les Mines CCH (Québec) Inc. have validly amalgamated under Part IA of the Companies Act and are continued as one single company under the name of Les Ressources Camchib Inc. from 14 March 1981, namely the date shown in its certificate of amalgamation, the validity of which certificate is hereby confirmed.
- Continuance      **3.** Mines d'Amiante United Inc. is validly continued under Part IA of the Companies Act from 6 May 1982, namely the date shown in its certificate of continuance, the validity of which certificate is hereby confirmed.
- Coming into force      **4.** This Act comes into force on the day of its sanction.
