CHAPTER 116

An Act respecting the municipality of Saint-Charles-de-Mandeville

[Assented to 18 December 1982]

Preamble. WHEREAS it is expedient to specify the territorial limits of the municipality of Saint-Charles-de-Mandeville and annex certain territories thereto;

HER MAJESTY, with the advice and consent of the National Assembly of Québec, enacts as follows:

Annexation of territory. **1.** The territory described in Schedule 1 forms part of the territory of the municipality of Saint-Charles-de-Mandeville.

Annexation of territory. **2.** The territory described in Schedule 2 forms part of the territory of the municipality of Saint-Charles-de-Mandeville.

Validity of acts. **3.** The lack of jurisdiction of the mayor, councillors and officers of the municipality of Saint-Charles-de-Mandeville from 14 March 1907 to the date of the coming into force of this Act does not entail nullity of the acts performed by those persons in the discharge of their duties as members of the council or officers of the municipality in regard to the territories mentioned in sections 1 and 2 of this Act.

Coming into force. **4.** This Act comes into force on the day of its sanction.

SCHEDULE 1

Territory annexed to the municipality of Saint-Charles-de-Mandeville by chapter 9 of the statutes of 1907

A territory comprising, with reference to the cadastre of the parish of Saint-Gabriel-de-Brandon, the lots or parts of lots and their present and future subdivisions and the roads, lakes, watercourses or parts thereof, the whole comprised in the limits hereinafter described, to wit: starting from the west corner of lot 1 of the fifth range southwest of the township of Peterborough thence, successively, the following lines and boundaries: part of the northwest line of the township of Peterborough to the northeast line of lot 16 of the fifth range southwest; the northeast line of the said lot; the northeast line of ranges A-east, A-west and B; the northeast line of lots 92, 91, 90, 89, 88 and 87; the southeast line of lot 87 and part of the southeast line of lot 89; the northeast line of lot 93Q; the southeast line of lots 93Q, 93P, 93O, 93M and 93L; the northeast line of lots 123, 122A, 122, 121, 120, 119, 118, 117, 116, 115 and 114, the last line extended to the centre line of the Maskinongé river; the centre line of the said river, downstream to the low water line of lake Maskinongé; the said low water line of lake Maskinongé to the centre line of the Matambin river; the said centre line to the extension of the northwest line of lot 134; the said extension line and the said northwest line; the northwest line of lots 133B, 133A and part of lot 133 to the southwest line of the township of Peterborough; finally, the said southwest line to the starting point.

SCHEDULE 2

Part of the territory of the parish municipality of Saint-Gabriel-de-Brandon to be annexed to the municipality of Saint-Charles-de-Mandeville

A territory comprising, with reference to the cadastre of the parish of Saint-Gabriel-de-Brandon, lots 94 to 97, 97A and 98 to 113 and the roads, watercourses or parts thereof, the whole comprised within the limits hereinafter described, to wit: starting from the north corner of lot 94; thence, successively, the following lines and boundaries: the northeast line of the said lot extended to the centre line of the outlet of lake Mandeville; the centre line of the said outlet to the northeast line of lot 97; the northeast line of the said lot, southeasterly, and extended to the centre line of the Maskinongé river; the centre line of the said river, in a generally westerly and south-

westerly direction, to its intersection with the extension of the southwest line of lot 113; the said extension and the said southwest line; finally, the northwest line of lots 113 to 98, 97A, 97, 96, 95 and 94 in retrograding order, to the starting point.
