## CHAPTER 1

An Act granting to Her Majesty moneys required for the expenses of the Government for the fiscal year ending 31 March 1982, and for other purposes connected with the public service

[Assented to 28 May 1981]

MOST GRACIOUS SOVEREIGN,

Preamble. WHEREAS it appears, by a message from the Honourable Jean-Pierre Côté, P.C., Lieutenant-Governor of this Province, and the estimates accompanying the same, that the sums hereinafter mentioned are required to defray certain expenses of the Government of the Province, not otherwise provided for, for the fiscal year ending 31 March 1982, and for other purposes connected with the public service; May it therefore please Your Majesty that it be enacted, and be it enacted by the Queen's Most Excellent Majesty, with the advice and consent of the National Assembly of Québec, that:

Short title. **1.** This Act may be cited as *The Appropriation Act No. 1, 1981-1982*.

1981-1982. **2.** There shall and may be taken out of the consolidated revenue fund of this Province a sum not exceeding, in all, \$1 534 641 608.33 for defraying, for the fiscal year ending 31 March 1982, the charges and expenses of the Government and public service of the Province, not otherwise provided for, being the aggregate of

(a) one-twelfth of the amount of the appropriations under each program of the estimates of the Province, for the said fiscal year, as laid before the National Assembly at the present session of the Legislature, viz.: \$1 370 526 775.00;

(b) an additional one-twelfth of the appropriations to be voted for program 8 entitled "Rehabilitation" of the Ministère des Affaires sociales, viz.: \$38 825 950.00;

(c) an additional one-sixth of the appropriations to be voted for program 5 entitled "Support to Municipalities and Local and Regional Recreational Organizations" of the Ministère du Loisir, de la Chasse et de la Pêche, viz.: \$5 393 333.33;

(d) an additional six-twelfths of the appropriations to be voted for program 9 entitled "School Transportation" of the Ministère des Transports, viz.: \$119 895 550.00.

**3.** Detailed accounts of all moneys expended under this Act shall be laid before the Legislature of the Province, in conformity with section 72 of the Financial Administration Act (R.S.Q., chapter A-6).
