CHAPTER 42

An Act to annex certain territories to
the territory of the municipality of Havre Saint-Pierre

[Assented to 18 June 1981]

Preamble. WHEREAS it is in the interest of the municipality of Havre Saint-Pierre that its territory be extended;

HER MAJESTY, with the advice and consent of the National Assembly of Québec, enacts as follows:

Annexation of
territory.

1. The following territory is annexed to that of the municipality of Havre Saint-Pierre:

Description.

A territory situated in the townships of Longfellow, Parker, Laurin, Vigneau, Puyjalon, Têtu, Cugnet, Ternet, Beaussier, Courtemanche and Des Herbiers, and comprising part of the Gulf of Saint Lawrence, not presently a part of any separate local municipality in the municipal county of Saguenay and comprising, with reference to the original survey or to the cadastres of the said townships, as the case may be, all the lots or parts of lots and the blocks or parts of blocks and their present and future subdivisions and the roads, highways, railway rights of way, islands, lakes and watercourses or parts thereof, the whole comprised within the perimeter hereinafter described, to wit: starting from the northeast corner of the township of Laurin; thence, successively, the following lines and boundaries: the east line of the township of Laurin and part of the east line of the township of Têtu; part of the north line of the township of Des Herbiers to the centre line of the de la Corneille river; the centre line of the de la Corneille river and lakes Turgeon and Tanguay downstream and skirting on the right the islands closest to the left bank and on the left the islands closest to the right bank, to the mouth of the de la Corneille river in the Gulf of Saint Lawrence; the shore of the Gulf, westerly to a straight line bearing astronomical south at 62°55'15" W. longitude; the latter line for a distance of sixteen (16) kilometres; another

straight line bearing astronomical west to its intersection with a straight line bearing approximately astronomical S. 9°20' E. originating at the intersection between the centre line of the Mingan river and the extension across the said river of the bank of the Gulf of Saint Lawrence; the said line bearing approximately S. 9°20' E. and the centre line of the Mingan and Manitou, (east branch), rivers and lakes Gros Diable and Manitou, skirting on the right the islands closest to the right bank and on the left the islands closest to the left bank to the north line of the township of Cugnet; the said north line; part of the west line of the township of Vigneau and the west line of the township of Longfellow; finally, the north line of the townships of Longfellow, Parker and Laurin to the starting point.

Present
territory.

However, the present territory of the municipality of Havre Saint-Pierre is to be excluded from that territory and is described as follows: that part of the townships of Beaussier and of Ternet, comprising a territory of about eight kilometres and four thousand six hundred and seventy-two one-hundred-thousandths (8.04672 km) in frontage by four kilometres and eighty-two thousand eight hundred and three one-hundred-thousandths (4.82803 km) in depth, comprising the islands situated opposite and near the north bank of the Gulf of Saint Lawrence; the whole bounded as follows: on the south, by the Gulf of Saint Lawrence; on the west, by a straight line measuring four kilometres and eighty-two thousand eight hundred and three one-hundred-thousandths (4.82803 km), starting from pointe aux Morts in a northeasterly southwesterly direction; on the east, by another straight line also measuring four kilometres and eighty-two thousand eight hundred and three one-hundred-thousandths (4.82803 km), starting from the mouth of the des Caps Blancs river in the same direction as the west limit; on the north, a straight line meeting, at the said depth, the two abovementioned lines.

Indemnity.

2. The municipality of Havre Saint-Pierre agrees to pay to the county corporation of Saguenay an indemnity of \$ 15 000.00 payable in two equal instalments, the first before 1 November 1981 and the second before 1 March 1982.

Coming
into force.

3. This Act comes into force on the day of its sanction but has effect from 1 January 1982.
