CHAPTER 61

An Act respecting the annexation of certain lots
of the cadastre of the parish of Saint-Raymond
to the town of Saint-Raymond

[Assented to 19 December 1981]

Preamble. WHEREAS, on 9 December 1963, the municipal corporation of the town of Saint-Raymond passed the first reading of by-law number 131 respecting the annexation of certain lots situated outside its territory for the setting up of an industrial park on certain of the lots and the operation of a site for the burying of refuse on certain other lots;

Whereas by-law number 131 was accepted by the municipal corporation of the parish of Saint-Raymond at a meeting held on 7 January 1964;

Whereas all public notices were given and the meetings of the electors-proprietors held, the latter having unanimously decided in favour of the annexation;

Whereas, on 10 February 1964, the second reading of the by-law was passed by the town and adopted by a resolution of the municipal council of the parish of Saint-Raymond at a meeting held on 2 March 1964;

Whereas all the necessary documents were sent for approval to governmental authorities and whereas no approval was published in the *Gazette officielle du Québec* due to omission.

Whereas the town passed by-laws which were approved, to purchase land and carry out works on the said lots;

HER MAJESTY, with the advice and consent of the National Assembly of Québec, enacts as follows:

Annexa-
tion of
territory.

1. The territory described in the schedule is detached from the municipality of the parish of Saint-Raymond and annexed to the town of Saint-Raymond.

Validity of
acts. **2.** The lack of jurisdiction of the mayor, councillors and officers of the town of Saint-Raymond from 1 April 1964 to the coming into force of this Act in the territory described in the schedule does not entail the nullity of the acts done by those persons in the discharge of their duties as members of the council or officers of that town.

Effect. **3.** Section 1 has effect as from 1 April 1964.

Coming
into force. **4.** This Act comes into force on the day of its sanction.

SCHEDULE

A territory presently forming part of the municipality of the parish of Saint-Raymond comprising, with reference to the cadastre of the said parish, that part of lots 500 to 506 comprised within the limits hereinafter described, to wit:

Starting from the point of intersection between the northwest line of lot 500 and the southwest line of the right of way of the Québec and Lake St-John Railway Company, lot 773; thence, successively along the following lines and limits: the southwest and west sides of the said right of way, southeasterly and southerly, to its meeting point with the southeast line of lot 506; part of the southeast line of lot 506, southwesterly to the southwest line of the said lot; the southwest line of lots 506, 505, 504, 503, 502, 501 and 500; finally, part of the northwest line of lot 500, to the starting point.
