



CHAPTER 17

An Act granting to Her Majesty moneys required for the expenses of the Government for the fiscal year ending 31 March 1981, and for other purposes connected with the public service

[Assented to 18 June 1980]

MOST GRACIOUS SOVEREIGN,

Preamble. WHEREAS it appears, by a message from the Honourable Jean-Pierre Côté, P.C., Lieutenant-Governor of this Province, and the estimates accompanying the same, that the sums hereinafter mentioned are required to defray certain expenses of the Government of the Province, not otherwise provided for, for the fiscal year ending 31 March 1981, and for other purposes connected with the public service; May it therefore please Your Majesty that it be enacted, and be it enacted by the Queen's Most Excellent Majesty, with the advice and consent of the National Assembly of Québec, that:

title.

1. This act may be cited as *The Appropriation Act No. 2, 1980-1981*.

2. There shall and may be taken out of the consolidated revenue fund of this Province a sum not exceeding, in all, \$10 711 993 175 for defraying, for the fiscal year ending 31 March 1981, the charges and expenses of the Government and public service of the Province, not otherwise provided for, being the amount of each of the various programmes set forth in the Schedule to this act, less the amounts voted under The Appropriation Act No. 1, 1980-1981 and the amounts authorized by special warrants No. 1 and No. 2 dated 23 May 1980.

3. Detailed accounts of all moneys expended under this act shall be laid before the Legislature of the Province, in conformity

with section 72 of the Financial Administration Act (R.S.Q., c. A-6).

4. The application of all sums expended under this act shall also be accounted for to Her Majesty.

5. This act shall come into force on the day of its sanction.

SCHEDULE

Sums granted to Her Majesty, by this act, for the fiscal year ending 31 March 1981, with indication of the purposes for which they are granted. The amount so voted is \$10 711 993 175, being $\frac{3}{4}$ of each of the programmes of this Schedule, except programme 2 of the Ministère de l'agriculture, des pêcheries et de l'alimentation and of the Ministère des affaires sociales, for which the sums of \$1 705 000 and \$34 500 000, respectively, have been authorized by special warrants No. 1 and No. 2 under section 41 of the Financial Administration Act (R.S.Q., c. A-6) on 23 May 1980, $\frac{1}{4}$ having been voted under the Appropriation Act No. 1, 1980-1981.
