



CHAPTER 55

An Act respecting the parish
municipality of Saint-Antonin

[Assented to 19 December 1980]

HER MAJESTY, with the advice and consent of the National Assembly of Québec, enacts as follows:

Electoral
districts.

1. Notwithstanding Chapter II of Part I of the Act respecting elections in certain municipalities (1978, c. 63), the division of the municipality into electoral districts must allocate an equal number of districts to each of the territories described in Schedules I and II.

Repeal
prohib-
ited.

2. By-law number 176 of the parish municipality of Saint-Antonin passed on 5 August 1980 shall not be repealed.

Applica-
bility.

3. Section 1 applies for the sole purposes of the general elections provided for 1981 and 1984 and of any election subsequent to each of those elections held before the general election provided for 1987.

Coming
into force.

4. This act comes into force on the day of its sanction.

SCHEDULE I

OFFICIAL DESCRIPTION

A territory now forming part of the parish municipality of Saint-Antonin, municipal county of Rivière-du-Loup, comprising with reference to the cadastre of the parish of Saint-Antonin the lots or parts of lots and their present and future subdivisions as well as the roads, highways, islands, lakes, waterways or parts thereof, the whole contained within the limits hereinafter described, to wit: starting from the top of the north angle of lot 1 of range I; thence, successively, the following lines and boundaries: the northeast line of lots 1 of range I, 37 of range II, and 87 and 88 of range III, the said northeast line extended across the public roads it meets; part of the southeast line of range III to the northeast line of range IV West; the northeast and southeast lines of the said range; the southeast line of range VII; the southwest line of lots 420 of range VII and 355 of range VI; the northwest line of lot 355, and part of the northwest line of lot 354 of the said range to the southwest line of lot 289 of range V; the southwest line of lots 289 and 291; the said line across the river it meets, and extended to the centre line of the Rivière du Loup; the centre line of the said river downstream to the extension of the south line of lot 227 of the Southwest range; the said extension and a broken line bounding on the south lots 227, 225, 224, 223, 221, 220, 219, 218, 217, 216, 214 and 213 of the said Southwest range; the northwest line of the said lot 213; the southwest side of the right of way of the public highway bounding on the northeast the said lot 213, northwesterly to the extension of the northwest line of lot 159 of the Northeast range; the said extension and the said northwest line, that northwest line extended across the Rivière du Loup; part of the southwest line and the northwest line of lot 158 of the Northeast range; the northwest line of lot 153 of the said range; finally, the northwest line of range I to the starting point.

SCHEDULE II

OFFICIAL DESCRIPTION

A territory now forming part of the parish municipality of Saint-Antonin, municipal county of Rivière-du-Loup, comprising with reference to the cadastre of the parish of Saint-Antonin the lots or parts of lots and their present and future subdivisions as well as the roads, highways, railway right of way, islands, lakes, waterways, or parts thereof, the whole contained within the limits hereinafter described, to wit: starting from the top of the north angle of lot 1 of the Northeast range, township of Whitworth;

thence, successively, the following lines and boundaries: the northeast line of the said range and its extension to the centre line of the Rivière Verte; the centre line of the said river, in a generally southerly direction, to the extension of the northeast line of lot 134 of range IV East; in the said range, the said extension and part of the northeast line of the said lot and the northeast line of lots 135 and 136; the southeast line of the said lot 136, that line extended across the Rivière Verte; the southwest line of lots 136 to 121 inclusively; the northwest line of the said lot 121; part of the southwest line of the Southwest range, township of Whitworth, northwesterly to the northwest line of lot 2 of the said range; finally, the said northwest line and its extension across a public highway (highway number 185) and the northwest line of lot 1 of the Northeast range, township of Whitworth, to the starting point.
