85.	TM:	That's what's selling right now on the market, in the downtown core.	
86.	VR:	Yeah. Yeah.	
87.	TM:	You know, so,	
88.	VR:	Yeah, yeah. And the front, you do the bigger ones, right?	
89.	TM:	Yeah, the front I'll make 1,200.	
90.	VR:	Yeah.	
91.	TM:	And let's say, the guy's got money, he'll buy two 1,200, that's 2,400, and he has himself, 3 bedrooms, you understand?	00:06:00

100.	VR:	Maybe there's euh, you gonna find somebody, who's gonna buy, 6, 7, 8.	
101.	TM:	Oh, I'm gonna find somebody who's gonna buy the whole project before we start - I think.	
102.	VR:	Really?	
103.	TM:	<i>E facciamo un po di meno</i> (trad: and will do a bit less), and at least we pick up where we have to faster, you know.

105.	TM:	That's what I was thinking, anyway, that, will be euh,	
106.	VR:	What about the one on Mon, on Crescent, there? Mountain.	
107.	TM:	(rire) The one on Mountain there, Tony there, at the beginning he wasn't too hot. Now

109.		Now, he's in love with it, because he knows what it is the square foot. What Giorgio wants. Because he wanted me to go buy at Giorgio's piece, you understand?
