It is my fervent hope in writing this statement, that the Commission will choose NOT to include its "preavis" in its final report.

Thank you for your consideration in advance.


#### STATEMENT SOLEMNLY AFFIRMED

I wish to succinctly state three points:

1. As a City Councillor, 1986-2009, I met over the course of each year dozens, indeed perhaps a hundred or more citizens/ individuals in meetings. I have absolutely no recollection of me being at a meeting with Mr. Tony Magi in the time period specified, August 2003, almost 12 years ago, even though Mr. Magi says I was there with him. (Further, I understand that I am not heard anywhere on the wiretap).
2. Therefore, I categorically deny agreeing to support anything to do with his alleged request to me of August 2003.
3. Most critically, between November 2001 and approximately Spring 2005, I was a member of the Opposition Party, Vision Montreal of Pierre Bourque. Our Party and myself were a minority on City Council and I was the one Opposition member, one of six, on the Cote des Neiges/Notre Dame de Grace Borough Council. It would have made no sense whatsoever to approach me and to expect me to be able to affect Any zoning change to what was possibly going to be a Borough City Hall or any other zoning change, as I would have virtually no influence on a decision like that, being an opposition City Councillor in August 2003, and as I said, only one of six on the Borough Council, the only Opposition member, the other five being with the Majority Party.
