

AFFIDAVIT

I, Ronald McCallum, domiciled and residing at [REDACTED]
[REDACTED] solemnly and under oath declare:

1. I totally refute the allegations made by Witness A on June 12, 2014 (Pages 267 to 274);
2. Georges Mamelonet personally contacted me to be his official agent, **and not his fund raiser**, for the 2008 electoral campaign. The description of an official agent does not resemble that of a « collecteur de fonds » I do not believe there was an official collecteur des fonds on Georges' team; (Page 267, line 5)
3. The Gaspé liberal association is a small but tight group and everyone that collects funds for the association always solicits the same donors that they have been soliciting for years. As Official agent I had to administer the budget determined by the director of elections and make sure we respected all laws and limitations in place; (Page 267, line 5)
4. I totally refute the allegation that I solicited a contribution from Roche, or any employee or associate of Roche for the electoral campaign of Georges Mamelonet. If witness A made electoral contributions it must have been done at the provincial association level, and most certainly did not pass in my hands; (Page 267, line 13)
5. It is totally incorrect that Kwatroe provided resources for the electoral Campaign. As official agent I put in many hours in managing the campaign activities, as did many others including Martin Crousset my associate, and our secretary, all of whom have a history of volunteering for elections. It was our personal choice to volunteer for the Liberal party and had nothing to do with Kwatroe; (Page 270, lines 3, 4 and 5)
6. Witness A has the right to write what he wants and since his ultimate reason for supporting Georges was probably a return of the elevator base. I personally accepted to accompany Georges in his 2008 campaign because I believed he was the right man for the job; (Page 270, lines 9, 10 and 11)

7. I am not aware of what witness A is referring to at page 274 of the transcript. What might have gone on at the provincial level had nothing to do with or local activities and Georges Campaign and it had no bearing on the results;
8. The above-mentioned facts are true to my personal knowledge.
