EXPLANATORY NOTE

The object of this bill is to authorize the Government to pay out of the consolidated revenue fund the sum of \$6 217 967 741.67, being slightly over one-fourth of the appropriations appearing in the estimates of expenses of Québec for the fiscal year 1988-89.

Appropriation Act No. 1, 1988-89

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

7 **1.** The Government may take out of the consolidated revenue fund
a sum not exceeding \$6 217 967 741.67 to defray a part of the expenses
of Québec proposed in the estimates for the fiscal year 1988-89 as laid
before the National Assembly, not otherwise provided for.

That sum is apportioned as follows:

(1) \$5 839 701 800.00, being one-fourth of the appropriations to be voted for each of the programs appearing in the estimates of expenses of the Government for the said fiscal year;

(2) \$68 103 350.00, being an additional one-fourth of the appropriations to be voted for Program 3, "Real Estate Assessment", of the Ministère des Affaires municipales;

(3) \$2 985 783.33, being an additional two-twelfths of the appropriations to be voted for Program 5, "Relations with Municipalities", of the Ministère des Affaires municipales;

(4) \$22 669 250.00, being an additional one-fourth of the appropriations to be voted for Program 2, "Farm Financing", of the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation;

(5) \$37 482 633.33, being an additional two-twelfths of the appropriations to be voted for Program 3, "Private Education", of the Ministère de l'Éducation;

(6) \$665 066.67, being an additional two-twelfths of the appropriations to be voted for Program 4, “Forestry Financing”, of the Ministère de l’Énergie et des Ressources;

(7) \$3 799 866.67, being an additional two-twelfths of the appropriations to be voted for Program 2, “Management of the Treasury and of the Public Debt”, of the Ministère des Finances;

(8) \$4 962 675.00, being an additional one-twelfth of the appropriations to be voted for Program 1, “Development of Recreation, Sport and Outdoor Activities”, of the Ministère du Loisir, de la Chasse et de la Pêche;

(9) \$154 021 416.67, being an additional one-twelfth of the appropriations to be voted for Program 6, “Social Aid Benefits”, of the Ministère de la Main-d’oeuvre et de la Sécurité du revenu;

(10) \$83 575 900.00, being an additional one-fourth of the appropriations to be voted for Program 6, “School Transportation”, of the Ministère des Transports.
