# Bill 248

## **An Act respecting the National Theatre School of Canada**

WHEREAS the National Theatre School of Canada is a non-profit body and owns, uses or occupies immovables situated in the municipality of Montréal which are open to the public and used without pecuniary gain mainly for cultural, recreational, charitable and social purposes;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** The immovable situated at number 5030 St-Denis Street in the city of Montréal and used and occupied by the National Theatre School of Canada, is exempt from the payment of any real estate, municipal or school tax, in accordance with the provisions of subparagraph *a* of paragraph 10 of section 204 of the Act respecting municipal taxation (R.S.Q., chapter F-2.1), for the period from 1 January 1982 to 30 June 1987.

**2.** The immovable situated at number 360 Laurier Avenue East in the city of Montréal and belonging to the National Theatre School of Canada, is exempt from the payment of any real estate, municipal or school tax, in accordance with the provisions of subparagraph *a* of paragraph 10 of section 204 of the Act respecting municipal taxation, for the period from 1 January 1982 to 30 June 1987.

**3.** The immovable situated on the corner of Laurier Avenue and St-Denis Street in the city of Montréal, known and designated as original lot number THREE HUNDRED FIFTY-EIGHT (358) in the official plan and book of reference of the incorporated village of Côte St-Louis and belonging to the National Theatre School of Canada, is exempt from the payment of any real estate, municipal or school tax,

in accordance with the provisions of subparagraph *a* of paragraph 10 of section 204 of the Act respecting municipal taxation, with retroactive effect to 1 January 1982.

**4.** The immovable situated on the corner of Laurier Avenue and Henri-Julien Avenue in the city of Montréal, consisting of redivision ONE HUNDRED THIRTY-THREE of original lot ONE HUNDRED SEVENTY-FOUR (174-133) and of subdivision ONE of subdivision ONE HUNDRED FIFTY-FOUR of original lot TEN (10-154-1) in the official plan and book of reference of the incorporated village of Côte St-Louis and having belonged to the National Theatre School of Canada, is exempt from the payment of any real estate, municipal or school tax, in accordance with the provisions of subparagraph *a* of paragraph 10 of section 204 of the Act respecting municipal taxation, for the period from 1 January 1982 to 14 December 1984.

**5.** Sections 1 to 4 of this Act shall be deemed to be a recognition granted by the Commission municipale du Québec under paragraph 10 of section 204 of the Act respecting municipal taxation.
