

EXPLANATORY NOTE

The object of this bill is to authorize the Government to pay out of the consolidated revenue fund the sum of \$6 541 302 141.67, being slightly over one-fourth of the expenses appearing in the estimates of expenses of Québec for the fiscal year 1989-90.

Appropriation Act No. 1, 1989-90

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

2 **1.** The Government may take out of the consolidated revenue
10 fund a sum not exceeding \$6 541 302 141.67 to defray a part of the
expenses of Québec proposed in the estimates for the fiscal year
1989-90 as laid before the National Assembly, not otherwise provided
for.

That sum is apportioned as follows:

(1) \$6 145 346 575.00, being one-fourth of the appropriations to be voted for each of the programs appearing in the estimates of expenses of the Government for the said fiscal year;

(2) \$70 986 575.00, being an additional three-twelfths of the appropriations to be voted for Program 3, "Real Estate Assessment", of the Ministère des Affaires municipales;

(3) \$2 952 116.67, being an additional two-twelfths of the appropriations to be voted for Program 5, "Relations with Municipalities", of the Ministère des Affaires municipales;

(4) \$10 156 433.33, being an additional one-twelfth of the appropriations to be voted for Program 2, "Farm Financing", of the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation;

(5) \$39 201 416.67, being an additional two-twelfths of the appropriations to be voted for Program 3, "Private Education", of the Ministère de l'Éducation;

(6) \$14 411 825.00, being an additional one-twelfth of the appropriations to be voted for Program 2, "Forest Improvement", of the Ministère de l'Énergie et des Ressources;

(7) \$4 515 200.00, being an additional six-twelfths of the appropriations to be voted for Program 3, "Development of the Forest Industry", of the Ministère de l'Énergie et des Ressources;

(8) \$878 666.67, being an additional two-twelfths of the appropriations to be voted for Program 4, "Forestry Financing", of the Ministère de l'Énergie et des Ressources;

(9) \$3 699 333.33, being an additional two-twelfths of the appropriations to be voted for Program 2, "Financial Policy and Operations", of the Ministère des Finances;

(10) \$34 389 500.00, being an additional four-twelfths of the appropriations to be voted for Program 3, "Support of Government Corporations and Agencies", of the Ministère de l'Industrie, du Commerce et de la Technologie;

(11) \$5 119 766.67, being an additional one-twelfth of the appropriations to be voted for Program 1, "Development of Recreational, Sports and Outdoors Activities", of the Ministère du Loisir, de la Chasse et de la Pêche;

(12) \$158 708 641.70, being an additional one-twelfth of the appropriations to be voted for Program 5, "Social Aid Benefits", of the Ministère de la Main-d'oeuvre et de la Sécurité du revenu;

(13) \$908 566.67, being an additional one-twelfth of the appropriations to be voted for Program 7, "Income Security for Cree Hunters and Trappers", of the Ministère de la Main-d'oeuvre et de la Sécurité du revenu;

(14) \$10 252 083.33, being an additional seven-twelfths of the appropriations to be voted for Program 2, "Financial Assistance for Work Income", of the Ministère du Revenu;

(15) \$10 708 650.00, being an additional three-twelfths of the appropriations to be voted for Program 2, "Support for Volunteer Organizations", of the Ministère de la Santé et des Services sociaux;

(16) \$29 066 791.67, being an additional one-twelfth of the appropriations to be voted for Program 6, "School Transportation", of the Ministère des Transports.
