An Act to amend the Automobile Insurance Act

EXPLANATORY NOTES

This bill provides that the Régie de l'assurance automobile du Québec will pay the sum of \$60 000 000 into the consolidated revenue fund each year as reimbursement for the cost of health services required as a result of automobile accidents.

It provides, as well, the mode of indexing the amount and the terms and conditions of its payment.

In addition, it authorizes the Government to revise the amount of the annual payment from 1 January 1989 and every three years thereafter, taking account of changes in the cost of health services required as a result of automobile accidents.

Bill 19

An Act to amend the Automobile Insurance Act

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

1. The Automobile Insurance Act (R.S.Q., chapter A-25) is amended

(1) by replacing the heading of Title V by the following heading:

“FINANCIAL PROVISIONS”;

(2) by inserting, after the heading of Title V, the following:

“CHAPTER I

“FINANCING OF THE RÉGIE”

2. Section 152 of the said Act is amended by replacing the words “of this Act” in the eighth line of the first paragraph by the words and figure “and Chapter II of this title”.

3. The said Act is amended by inserting, after section 155, the following:

“CHAPTER II

“PAYMENT INTO CONSOLIDATED REVENUE FUND

“**155.1** The Régie shall pay into the consolidated revenue fund the sum of \$60 000 000, as reimbursement for the cost of health services required as a result of automobile accidents.

From the year 1987, the sum shall be indexed in the manner and at the time provided in section 119 of the Act respecting the Québec Pension Plan (R.S.Q., chapter R-9).

For the year 1986, the sum shall be paid in two equal instalments, the first not later than (*insert here the day and month falling 15 days after the date of assent to this Act*) and the second not later than 30 September. For subsequent years, the first instalment shall be paid not later than 31 March and the second not later than 30 September each year.

“**155.2** The sum paid by the Régie before (*insert here the date occurring 15 days after the date of assent to this Act*) shall be included in the revenue of the Government for the fiscal year ending 31 March 1986.

“**155.3** The Government may, from 1 January 1989 and every three years thereafter, taking account of changes in the cost of health services required as a result of automobile accidents, fix a sum different from that contemplated in section 155.1 and the terms and conditions of payment of the sum.

The second paragraph of section 155.1 does not apply in a year where the Government fixes a sum pursuant to this section.”

4. This Act comes into force on (*insert here the date of assent to this Act*).
