EXPLANATORY NOTE

*This bill replaces the schedule to the Act respecting the neighbourhood of Mont Sainte-Anne park for the purpose of changing the boundaries of the territory of the park.*

## Bill 126

### **An Act to amend the Act respecting the neighbourhood of Mont Sainte-Anne park**

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** The schedule to the Act respecting the neighbourhood of Mont Sainte-Anne park (1971, chapter 58) is replaced by the following schedule:

#### “SCHEDULE

A territory situated in the regional county municipality of the Côte-de-Beaupré comprised in the cadastre of the parishes of Saint-Féréol, Sainte-Anne and the seigneurie de la Côte-de-Beaupré, containing an area of 63 km<sup>2</sup>, the perimeter of which being described as follows:

Starting from a point situated on the right bank of the Sainte-Anne du Nord river in the dividing line between lots 545 and 546 of the first range of the cadastre of the parish of Saint-Féréol; thence, in a generally southwesterly direction, the right bank of the said river to the southwest limit of lot 611 of the cadastre of the parish of Sainte-Anne; thence, northwesterly, the southwest limit of lots 611 and 612 for a distance of 674.10 m; thence, southerly, a straight line for a distance of 223.69 m, namely to the dividing line between lots 612 and 613; southwesterly, a line perpendicular to the dividing line between the said lots for a distance of 393.80 m; thence, northwesterly, along the dividing line between lots 619 and 620 for a distance of 152.40 m; southwesterly, a line perpendicular to the dividing line between lots 619 and 620 for a distance of 262.73 m to the dividing line between lots 624 and 637;

thence, southeasterly, the dividing line between the said lots for a distance of 104.55 m; thence, on an azimuth of  $230^{\circ}09'20''$  a straight line to the dividing line between lots 637 and 639, namely for a distance of 148.89 m; thence, southeasterly, the dividing line between lots 637 and 639 for a distance of 108.31 m; thence, southwesterly, a straight line to the point of intersection of the northeast limit of the right of way of the former Saint-Féréol road (without cadastral designation) with the dividing line between lots 639 and 640; southeasterly, the said dividing line to a point situated 137.17 metres northwest of the northwest limit of the right of way of Bélanger boulevard; southwesterly, a straight line perpendicular to the center line of highway 360 to the southwest limit of lot 648; thence, northwesterly, the said limit to a point situated 1 205.94 m from the northwest limit of lot 2 of the cadastre of the parish of Sainte-Anne; thence, on an azimuth of  $230^{\circ}21'28''$  for a distance of 649.17 m to the dividing line between lots 27 and 29 of Range I; thence, northwesterly, the dividing line between lots 27 and 29 for a distance of 288.29 m, namely to the southeast limit of the right of way of the power line; thence, northwesterly, the southeast limit of the right of way of the said power line to the dividing line between lots 35 and 36 of Range I; thence, northwesterly, the dividing line between lots 35 and 36 for a distance of 535.80 m; thence, a broken line on the following azimuths and distances:  $237^{\circ}24'08'' - 30.07$  m;  $339^{\circ}24'28'' - 19.65$  m;  $234^{\circ}54'28'' - 128.86$  m; thence, northwesterly, the dividing line between lots 35 and 38 to the south limit of the northeast concession of the aux Chiens river; thence, southwesterly, the south limit of the said concession and of the Saint-Pierre concession; thence, northerly, the west limit of the Saint-Pierre concession; northeasterly, the northwest limit of lot 298 of the Saint-Pierre concession to the right bank of the aux Chiens river; thence, northwesterly, the right bank of the aux Chiens river to the extension of the northwest limit of lot 297 of the northeast concession of the aux Chiens river; thence, northeasterly, the northwest limit of lot 297; thence, northeasterly, a line parallel to and 731.52 m from the northwest limit of the cadastre of the parish of Saint-Féréol for a distance of 3 834.53 m; thence, a broken line, on the following azimuths and distances:  $351^{\circ}40'00'' - 1 729.19$  m;  $36^{\circ}12'00'' - 1 695.15$  m;  $98^{\circ}49'00'' - 2 054$  m, to a point in the southwest limit of the Saint-Nicolas concession of the cadastre of the parish of Saint-Féréol; thence, southeasterly, the southwest limit of the Saint-Nicolas concession for a distance of 437.14 m; thence, on an azimuth of  $49^{\circ}00'00''$  a distance of 381 m; thence, on an azimuth of  $137^{\circ}09'$  a distance of 555.71 m; thence, on an azimuth of  $139^{\circ}00'$  a distance of 1 286.10 m, namely to the dividing line between lots 97 and 98; thence, southwesterly, the dividing line between lots 97 and 98 of the Saint-Nicolas concession for a distance of 381 m; thence, southeasterly, the southwest limit of the Saint-Nicolas concession

for a distance of 683.42 m; thence, on an azimuth of  $222^{\circ}24'$  a distance of 979.38 m, the said point being situated on lot 208 of the Saint-Julien concession; thence, on an azimuth of  $140^{\circ}01'$  a distance of 38.22 m; thence, on an azimuth of  $222^{\circ}24'$  a distance of 117.19 m; thence, southeasterly, along the dividing line between lots 206 and 207 for a distance of 110.70 m; thence, on an azimuth of  $228^{\circ}57'$  a distance of 116.95 m; thence, southeasterly, along the dividing line between lots 205 and 206 for a distance of 45.72 m; thence, on an azimuth of  $228^{\circ}57'$  a distance of 233.87 m; thence, southeasterly, along the dividing line between lots 203 and 204 for a distance of 121.92 m; thence, on an azimuth of  $228^{\circ}57'$  a distance of 117.92 m; thence, southeasterly, along the dividing line between lots 202 and 203 for a distance of 178.46 m; thence, on an azimuth of  $228^{\circ}57'$  a distance of 174.22 m; thence, southeasterly, the dividing line between lots 201 and 202 for a distance of 294.13 m; thence, on an azimuth of  $228^{\circ}57'$  a distance of 12.67 m; thence, southeasterly along the dividing line between lots 382 and 386 for a distance of 457.20 m; thence, on an azimuth of  $228^{\circ}57'$  a distance of 96.68 m; thence, southeasterly along the dividing line between lots 386 and 388 for a distance of 11.24 m; thence, on an azimuth of  $208^{\circ}31'$  a distance of 63.67 m; thence, southeasterly along the dividing line between lots 387 and 390 for a distance of 438.88 m, the said point being situated in the northwest limit of the right of way of the power line; thence, southwesterly, the northwest limit of the said right of way to the southwest limit of the right of way of the road (St-Julien range); thence, southeasterly, the southwest limit of the right of way of the said road for a distance of approximately 435 m, namely to the residual part of lot 392 remaining the property of Henri Fortier following the expropriation for the purposes of Mont-Sainte-Anne park; thence, southwesterly, the northwest limit of the said residual part for a distance of 54 m; thence, southwesterly, a straight line to a point being the intersection of the southeast limit of the right of way of the power line with the dividing line between lots 408 and 410 of the St-Julien concession; thence, southwesterly, the southeast limit of the right of way of the power line to a point situated on the dividing line between lots 548 and 544-28; thence, southeasterly, the northeast limit of lots 548, 547 and 546 to the starting point.

That part of the right of way of highway 360 running across the said territory being withdrawn.

The whole as shown on the plans prepared by Henri Morneau, landsurveyor, on 25 April 1986 and bearing number P-8575, the original copy of which being kept at the Service de l'acquisition d'immeubles du Ministère du Loisir, de la Chasse et de la Pêche.
