EXPLANATORY NOTES

The purpose of this bill is the repeal of Acts or statutory provisions considered outdated, superfluous or spent and therefore omitted from the Québec Revised Statutes of 1888, 1909, 1925, 1941, 1964 and 1977.

The schedule introduced by the bill contains almost three hundred statutes, which it is proposed to repeal in their entirety. Also included in the schedule are approximately three hundred sections and thirty preambles that were excluded from the repeal schedules.

This bill completes a similar Act passed in 1985 (chapter 37) and includes the statutes omitted in the Revised Statutes of 1977.

Bill 1

An Act to repeal Acts and statutory provisions omitted upon the revision of statutes in 1888, 1909, 1925, 1941, 1964 and 1977

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

1. The Acts and statutory provisions appearing in the Schedule are repealed.

2. The Government may, by order made before 1 July 1988, exclude any Act or statutory provision from the Schedule.

The order shall be laid before the Commission des institutions and have effect only if approved by it prior to 1 July 1988.

3. This Act comes into force on (*insert here the date of assent to this Act*), except section 1 which will come into force on 1 July 1988.
