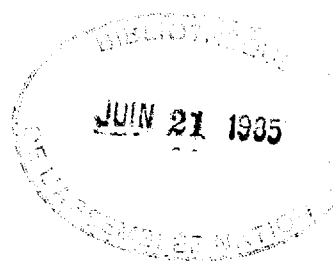

EXPLANATORY NOTES

The purpose of this Bill is the repeal of Acts and statutory provisions considered outdated, superfluous or spent and therefore omitted from the Québec Revised Statutes of 1888, 1909, 1925, 1941 and 1964.

The Schedule introduced by the Bill contains almost one thousand five hundred statutes, which it is proposed to repeal in their entirety. Also included in the Schedule are approximately two thousand sections, one hundred and sixty preambles, twenty schedules and nine forms that were excluded from the Schedule of Repeals to the Revised Statutes.

To which must be added the coming into force sections of statutes revised in 1941 and 1964, which had remained in force pursuant to the Acts respecting the Revised Statutes, 1941 and 1964. The sections do not appear in the Schedule since their repeal is prescribed by section 2 of the Bill. Over six hundred sections will thereby be repealed.

An Act to repeal Acts and statutory provisions omitted upon the revision of statutes in 1888, 1909, 1925, 1941 and 1964

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

1. The Acts and statutory provisions appearing in the Schedule are repealed.

2. The sections dealing with the coming into force of Acts listed in the Schedule of Repeals to the Revised Statutes, 1941 and 1964, are repealed.

3. This Act shall operate notwithstanding the provisions of sections 2 and 7 to 15 of the Constitution Act, 1982 (Schedule B to the Canada Act, chapter 11 in the 1982 volume of the Acts of the Parliament of the United Kingdom).

4. This Act comes into force on 1 July 1986.

The Government may, by Order in Council made before the date on which the Act comes into force, exclude any Act or statutory provision from the Schedule.

The Order in Council shall be laid before the Commission des institutions and have effect only if approved by it prior to 1 July 1986.
