An Act respecting the erection of
the municipality of Saint-Pierre-de-Lamy

WHEREAS the citizens of Saint-Pierre-de-Lamy wish to have an autonomous administration consisting of a mayor and councillors;

Whereas it is in the interest of the population that their petition be granted;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

1. The territory described in the schedule is erected into a rural municipality under the name of “municipality of Saint-Pierre-de-Lamy”, which is governed by the Municipal Code.

2. This Act comes into force on the day of its sanction.

SCHEDULE

Description of the boundaries of the
territory of the municipality of Saint-Pierre-de-Lamy

The present territory of the municipality of Saint-Pierre-de-Lamy, organized pursuant to the Act respecting municipal organization of certain territories (R.S.Q., chapter O-8), situated in the township of Demers and the seigniory of Madawaska, in the regional county municipality of Témiscouata, and comprising, with reference to the cadastre of the township of Demers and the original survey, or to the cadastre of the seigniory of Madawaska, the lots or parts of lots and their present and future subdivisions as well as the roads, highways, lakes, watercourses or parts thereof, the whole comprised within the limits hereinafter described, to wit: starting from the apex of the north angle of lot 25 of range VII Lac-Témiscouata of the cadastre of the seigniory of Madawaska; thence, successively, the following lines and boundaries: with reference to the said cadastre, the northeast line of range VII Lac-Témiscouata; part of the northeast line of range VIII Lac-Témiscouata to the southeast line of lot 50 of range B Lac-Témiscouata; the said southeast line; the southwest side of the right of way of highway number 293 southeasterly to the west line of Rivière-Caldwell range as shown on a plan prepared by L.-P. de Courval and Robert Dorval, land surveyors, dated 4 October 1938 and deposited in the records of the land survey service of the Ministère de l'Énergie et des Ressources; with reference to the said plan, the west line of Rivière-Caldwell range southerly to the north line of lot 1 of Rivière-Caldwell range of the cadastre of the seigniory of Madawaska; the extension of the said north line westerly to a point located five thousand and thirty metres (5 030 m, that is 250 chains) from the northwest bank of lake Témiscouata, measured along the said north line and the said extension; a line running southwesterly, parallel to the northwest line of lots 1 to 21 of the said Rivière-Caldwell range to the northeast line of lots 200 to 219 of the cadastre of the parish of Saint-Louis-du-Ha!-Ha!; part of the said northeast line northwesterly and the north line of lots 200 in declining order to 191, inclusively, of the said cadastre; with reference to the cadastre of the township of Demers, part of the south line of range IX to the dividing line between lots 27 and 28 of the said range; the said dividing line between lots in ranges IX and VIII; part of the dividing line between ranges VII and VIII southwesterly to the dividing line between lots 25 and 26 of said range VII; the said dividing line between lots; part of the dividing line between ranges VI and VII northeasterly to the dividing line between the townships of Demers and Hocquart; part of the said dividing line between townships southeasterly to the west line of range VIII Lac-Témiscouata of the cadastre of the seigniory of Madawaska; finally, a broken line bounding on the west and the north ranges VIII Lac-Témiscouata and VII Lac-Témiscouata of the said cadastre to the starting point.
