EXPLANATORY NOTES

This bill modifies certain judicial districts and corrects certain technical errors in chapter 7 of the statutes of 1975.

In addition, it provides for the creation of two new judicial districts: the district of Laval which will serve the City of Laval and the district of Longueuil which will serve certain municipalities of the south shore.

Finally, it provides concordance with the Courts of Justice Act and the Code of Civil Procedure.

Sec. 1. *This section modifies the composition of certain judicial districts and corrects certain technical errors in chapter 7 of the statutes of 1975; furthermore, it provides for the creation of two new judicial districts.*

This section proposes that:

(a) the judicial district of DRUMMOND be modified by the annexation of the municipalities of Saint-Bonaventure, Saint-Guillaume (village and parish), Saint-Joachim-de-Courval and Saint-Zéphirin-de-Courval presently in the district of RICHELIEU, of the municipality of Ulverton presently in the district of Saint-François, of the municipality of Saint-Nazaire d'Acton presently in the district of SAINT-HYACINTHE, of the municipalities of Sainte-Brigitte-des-Saults, Saint-Léonard (village and parish) and Sainte-Perpétue presently in the district of TROIS-RIVIÈRES;

(b) the judicial district of LAVAL be created to serve the municipality of the City of Laval;

(c) the judicial district of LONGUEUIL be created, with the chief place at Longueuil, to serve the municipalities of Chambly, Boucherville, Brossard, Candiac, Carignan, Delson, Greenfield Park, La Prairie, Le Moyne, Longueuil, Saint-Basile-le-Grand, Saint-Bruno-de-Montarville, Sainte-Catherine, Saint-Constant, Saint-Hubert, Sainte-Julie, Saint-Lambert, Saint-Rémi, Saint-Philippe, Saint-Mathieu and the Indian reserve of Caughnawaga;

(d) the judicial district of MÉGANTIC be amended by the annexation of the municipalities of Sainte-Agathe and Saint-Sylvestre presently in the district of QUÉBEC, of the municipalities of Beaulac, Disraëli, Garthby, Saint-Jacques-Le-Majeur, Saint-Julien, Sainte-Praxède and Straford presently in the district of SAINT-FRANÇOIS, of the municipalities of Courcelles, Lambton, La Guadeloupe, Saint-Evariste and Saint-Méthode de Frontenac presently in the district of BEAUCE;

An Act to amend the Territorial Division Act

HER MAJESTY, with the advice and consent of the Assemblée nationale du Québec, enacts as follows:

1. Section 10 of the Territorial Division Act (Revised Statutes, 1964, chapter 5), amended by sections 52 to 56 of chapter 10 of the statutes of 1965 (1st session) and by section 2 of chapter 8 of the statutes of 1971 and replaced by section 1 of chapter 7 of the statutes of 1975, is again amended:

(a) by replacing the first two lines by the following:

“10. The thirty-four judicial districts are named and composed as follows:”;

(b) by replacing paragraph 3 by the following paragraph:

“3. Beauce, Chief Place: Saint-Joseph-de-Beauce.

The judicial district of Beauce comprises the territory bounded as follows: starting from the north corner of lot 92 of the cadastre of the parish of Saint-Isidore; thence, successively, the following lines: a broken line dividing the cadastre of the parish of Saint-Henri-de-Lauzon from the cadastres of the parishes of Saint-Isidore and Saint-Anselme to the dividing line between lots 476 and 477 of the cadastre of the parish of Saint-Anselme; in that cadastre, a broken line dividing lot 477 from lots 476 and 475; the northeast line of lot 475; the northwest line of lot 469; the northeast line of lots 469 and 470; the northwest line of lots 397, 396, 395, 394, 393 and 392; the northeast line of lot 392; part of the dividing line between the Saint-Luc and Saint-Marc concessions; a broken line limiting the Sainte-Anne concession on the northeast and on the southeast, as the case maybe, in the cadastre of the parish of Sainte-Claire, a broken line dividing the

(e) *the judicial district of SAINT-MAURICE be modified by the annexation of the municipalities of Notre-Dame-de-Montauban and Saint-Rémi, presently in the district of QUÉBEC;*

(f) *that the errors concerning the perimeter or the list of municipalities of the judicial districts of Québec, Saint-Maurice, Beauharnois, Bedford, Chicoutimi, Drummond, Richelieu, Joliette and Trois-Rivières be corrected.*

Sainte-Claire northeast and Saint-Amable concessions from the Saint-Octave and Sainte-Elizabeth concessions; a broken line dividing the cadastre of the parish of Saint-Lazare from the cadastres of the parishes of Sainte-Claire and Saint-Malachie to the dividing line between ranges III and IV of the township of Buckland, in the cadastre of the parish of Saint-Malachie; in the latter cadastre and in the said township of Buckland, part of the dividing line between ranges III and IV; the dividing line between lots 24C and 25A of range IV; part of the dividing line between ranges IV and V; the dividing line between lots 28 and 29 of ranges V and VI; part of the northeast limit of the cadastre of the parish of Saint-Malachie; part of the northwest limit and the northeast limit of the cadastre of the parish of Saint-Léon-de-Standon to the centre line of the Etchemin river; the centre line of the said river southwesterly to the extension of the dividing line between ranges XII and XIII of the township of Ware; the said extension and the said dividing line between ranges; part of the dividing line between the townships of Ware and Langevin to the north corner of lot 23 of range XII of the township of Langevin; in the cadastre of that township, part of the dividing line between ranges XII and XIII; the northeast line of lot 17 of ranges XII and XI; part of the dividing line between ranges X and XI and part of the northeast line of the township of Langevin southeasterly; the Québec/United States boundary line in a generally southwest direction to the southwest line of the township of Risborough; the southwest line of the said township and its extension to the centre line of the Chaudière river; the centre line of the said river upstream to the extension of the southwest line of the township of Gayhurst; the said extension and the southwest line of the township of Gayhurst and part of the township of Aylmer; in the cadastre of the latter township, the southeast line of lots 10B of range I, 10C of range II, 10B of range III, 10 of range IV, 10C of range V and 10B of range VI; part of the dividing line between ranges VI and VII; the southeast line of lot 18 of range VII; part of the dividing line between ranges VII and VIII and part of the east line of the township of Aylmer; in the cadastre of the township of Dorset, the south line of lot 14 of range XIII and part of the dividing line between ranges XII and XIII; part of the southeast line of the township of Forsyth; part of the southwest and south lines of the township of Shenley; in the cadastre of that township, part of the dividing line between ranges IX South and X South; the north line of lot 4 of range X South; part of the dividing line between ranges X South and XI South; the north line of lot 12B of range XI South; part of the dividing line between ranges XI South and XII South; the north line of lots 33 of range XII South and 33B of range XIII South; part of the dividing line between ranges XIII South and XIV South; the north line of lot 36B of range XIV South; part of the

northwest line of the township of Shenley; part of the northeast and northwest lines of the township of Forsyth; in the cadastre of the township of Adstock, part of the dividing line between ranges XI and XII and part of the southeast line of lot 4 in ranges XII and XIII; part of the northeast line of the township of Adstock; in the cadastre of the parish of Saint-Ephrem-de-Tring, the southeast line of lot 529; part of the dividing line between ranges X and XI and the northwest line of lot 537; part of the northeast line of the township of Adstock; part of the southwest line of the township of Broughton; in the cadastre of that township, the southeast line of lot 26B of range IX to the southwest side of a public road; the southwest side of the said road to the southeast line of lot 24D of range XI; the southeast line of the said lot and the southeast line of lot 24B of range X; part of the dividing line between ranges IX and X; the southeast line of lot 23A of range IX; the southwest side of the road between ranges VIII and IX; the southeast line of lot 23C of range VIII for a distance of approximately 8 arpents; a straight line parallel to the road between ranges VIII and IX on the width of lots 24A and 24B; part of the northwest line of lot 25A of range VIII for a distance of approximately 8 arpents and its extension to the southwest side of the road between ranges VIII and IX; the southwest side of the said road to the extension of the southeast line of lot 25B of range VIII; the said extension and the said southeast line; the southwest side of the road between ranges VII and VIII to the southeast line of the township of Broughton; part of the said southeast line; in the cadastre of the parish of Saint-Victor-de-Tring, the southwest side of the road between ranges VI and VII to the extension of the southeast line of lot 713; the said extension and the said southeast line; the southwest side of the road between ranges V and VI; part of the southeast line of the township of Broughton and part of the dividing line between ranges III and IV of the said township; the dividing line between the cadastres of the township of Broughton and the parish of Saint-Séverin; part of the northwest line of the township of Broughton; a broken line dividing the cadastre of the parish of Saint-Sylvestre from the cadastres of the parishes of Saint-Séverin and Saint-Elzéar; a broken line limiting on the southwest and northwest the cadastre of the parish of Saint-Bernard; finally, another broken line dividing the cadastre of the parish of Saint-Lambert from the cadastre of the parish of Saint-Isidore to the starting point.

This judicial district includes the following municipalities: the towns of Beauceville, Lac Etchemin, Saint-Georges, Saint-Georges-Ouest, Saint-Joseph-de-Beauce and Sainte-Marie; the villages of Lac Poulin, Linière, Saint-Anselme, Saint-Bernard, Saint-Elzéar, Saint-Ephrem-de-Tring, Saint-Gédéon, Saint-Isidore, Saint-Ludger, Saint-Victor, Saint-Zacharie, Scott, Tring-

Jonction and Vallée-Jonction; the parish municipalities of L'Enfant-Jésus, Notre-Dame-des-Pins, Saints-Anges, Saint-Anselme, Saint-Benoît-Labre, Saint-Bernard, Sainte-Clothilde, Saint-Côme-de-Kennebec, Saint-Cyprien, Saint-Édouard-de-Frampton, Saint-Éphrem-de-Beauce, Saint-Frédéric, Sainte-Germaine-du-Lac-Étchemin, Saint-Gédéon, Saint-Georges-Est, Sainte-Hénédine, Saint-Hilaire-de-Dorset, Saint-Honoré, Saint-Isidore, Saint-Jean-de-la-Lande, Saint-Joseph-de-Beauce, Saint-Jules, Sainte-Justine, Saint-Léon-de-Standon, Saint-Luc, Saint-Malachie, Sainte-Marguerite, Saint-Martin, Saint-Nazaire-de-Dorchester, Saint-Odilon-de-Cranbourne, Saint-René and Saint-Séverin; the township municipalities of Gayhurst (Southeast part), Risborough and part of Marlow, Shenley; the municipalities of Aubert-Gallion, Lac Drolet, Saint-Alfred, Sainte-Aurélie, Saint-Benjamin, Saint-Elzéar-de-Beauce, Saint-François-de-Beauce, Saint-François-Ouest, Saint-Joseph-des-Érables, Saint-Louis-de-Gonzague, Saint-Philibert, Saint-Prosper, Saint-Robert-Bellarmin, Sainte-Rose-de-Watford, Saint-Sébastien, Saint-Simon-les-Mines, Saint-Théophile, Saint-Victor-de-Tring, Saint-Zacharie and Taschereau-Fortier; the municipality of Sainte-Claire less that part comprised in the cadastre of the parish of Saint-Lazare. It also comprises an unorganized territory formed by the township of Metgermette-Sud.”;

(c) by adding after the words “Coteau-du-Lac”, in the twenty-second line of the second paragraph of the description of the judicial district of Beauharnois (paragraph 4), the words “, Saint-Isidore”;

(d) by replacing the twenty-ninth to thirty-first lines of the second paragraph of the description of the judicial district of Bedford (paragraph 5) by the following: “Saint-Pierre-de-Véronne à Pike River, Stanbridge Station, Stukely-Sud and Venise-en-Québec; the parts of the city of”;

(e) by adding after the word “Lamarche” in the sixteenth and seventeenth lines of the second paragraph of the description of the judicial district of Chicoutimi (paragraph 7), the words “, Rivière-Éternité”;

(f) by replacing paragraph 8 by the following paragraph:

“8. Drummond, Chief Place: Drummondville.

The judicial district of Drummond comprises the territory bounded as follows: starting from the north corner of lot 1 of the cadastre of the parish of Saint-Léonard; thence, successively, the following lines: with reference to that cadastre, a broken line bounding the cadastre of the said parish on the northeast and southeast, to the corner of lot 106; the southeast line of lot 106; the northeast line of lot 109 and its extension to the centre line

of the Nicolet river; the centre line of the said river downstream to the extension of the southeast line of lot 121; the said extension and part of the said southeast line; in the cadastre of the township of Horton, the northeast line of lots 6 to 22; the southeast line of lot 22; part of the northeast line of the township of Simpson; in the cadastre of that township, the southeast line of lots 6 of range XII and 6B of range XI; part of the dividing line between ranges X and XI; the southeast line of lot 6 of range X; part of the dividing line between ranges IX and X; the southeast line of lot 12 of range IX; part of the dividing line between ranges VIII and IX; the northwest line of lot 20 of range IX; part of the dividing line between ranges IX and X; the southeast line of lot 22 of range IX; part of the dividing line between ranges VIII and IX; the southeast line of lot 24A of range VIII; part of the dividing line between ranges VII and VIII; part of the dividing line between the townships of Simpson and Kingsey; in the cadastre of the township of Kingsey, part of the dividing line between ranges IX and X; the northwest line of lot 18 of range X; part of the dividing line between ranges X and XI; the northwest line of lot 18 in ranges XI and XII; part of the dividing line between ranges XII and XIII; the northwest line of lot 19 of range XIII; part of the dividing line between the townships of Kingsey and Warwick; part of the dividing line between the townships of Warwick and Tingwick; in the cadastre of the township of Tingwick, the northeast line of lots 98 and 96; part of the dividing line between ranges I and II; the northeast line of lots 185, 186 and 187; part of the dividing line between ranges II and III; part of the southwest line of the township of Tingwick; the southeast line of the township of Kingsey and its extension to the centre line of the Saint-François river; the centre line of the said river upstream, running to the right of those islands closer to the right bank and to the left of those islands closer to the left bank, to the extension of the southeast line of the township of Durham; the said extension; the southeast and southwest lines of the township of Durham; part of the southwest line of the township of Wickham; in the cadastre of the parish of Saint-Théodore-d'Acton, the dividing line between lots 380 and 381 and part of the dividing line between ranges IX and X; part of the east line of the township of Upton and the south line of lots 326, 154 and 139 of the cadastre of the parish of Saint-Ephrem-d'Upton; part of the east line and the northeast line of the cadastre of the parish of Sainte-Hélène; the northeast line of the cadastre of the parish of Saint-Hugues; part of the southwest line of the cadastre of the parish of Saint-Guillaume-d'Upton; a broken line bounding, on the southwest and northwest, the des Chênes brook Second concession of the cadastre of the parish of Saint-David-de-Guire, to the northwest line of lot 914 of the said cadastre; with reference to that cadastre, the said northwest line and its extension to the

centre line of the des Chênes brook; the centre line of the said brook to the extension of the dividing line between lots 757 and 758; the said extension and the said dividing line between lots; the northeast line of lots 757 and 756; the dividing line between lots 745 and 746 extended to the centre line of the David river; the centre line of the said river upstream to the southeast line of the cadastre of the parish of Saint-David-de-Guire; part of the southeast line of the said cadastre and the southeast line of the cadastre of the parish of Saint-Pie-de-Guire, the latter extended to the centre line of the Saint-François river; the centre line of the said river upstream to the extension of the dividing line between lots 787 and 788 of the cadastre of the parish of Saint-Thomas-de-Pierreville; the said extension and the said dividing line between lots; part of the southwest line of the cadastre of the parish of Saint-Zéphirin-de-Courval; in that cadastre, the southeast line of lots 739 and 524; the southeast and northeast lines and part of the northwest line of lot 525; the dividing line between lots 494 and 495; a broken line dividing lots 494, 493 and 492 from lots 516, 517, 518 and 519; part of the northeast line of lot 492 to the extension of the northwest line of lot 490; the said extension and the northwest line of lots 490 to 484; part of the southwest line and the southeast and northeast lines of lot 482; the northeast line of lot 483; part of the northeast line of the said cadastre and a broken line bounding the Hartville range on the southwest; a broken line dividing the cadastres of the parishes of Sainte-Brigitte and Sainte-Perpétue from the cadastres of the parishes of Saint-Zéphirin-de-Courval and Sainte-Monique, to the dividing line between lots 356 and 357 of the cadastre of the parish of Sainte-Monique; in that cadastre, the said dividing line between lots; a broken line dividing lots 306 and 101 from lots 307 and 100; part of the southwest line and the northwest line of lot 77; finally, the northwest line of lots 1 to 14 of the cadastre of the parish of Saint-Léonard to the starting point.

This judicial district includes the following municipalities: the city of Drummondville; the town of Drummondville-Sud; the villages of Kingsey Falls, Notre-Dame-du-Bon-Conseil, Saint-Cyrille, Saint-Germain-de-Grantham, Saint-Guillaume and Saint-Léonard-d'Aston; the parishes of Notre-Dame-du-Bon-Conseil, Saint-Bonaventure, Sainte-Brigitte-des-Saults, Saint-Edmond-de-Grantham, Saint-Germain-de-Grantham, Saint-Guillaume, Saint-Joachim-de-Courval, Saint-Lucien, Saint-Majorique-de-Grantham, Saint-Nazaire-d'Acton, Sainte Perpétue and Saint-Zéphirin-de-Courval; the township municipality of Kingsey; the municipality of the united townships of Wendover and Simpson; the municipalities of Durham-Sud, Grantham-Ouest, Kingsey

Falls, L'Avenir, Lefebvre, Saint-Eugène, Saint-Léonard, Saint-Nicéphore, Ulverton and Wickham.”;

(g) by replacing paragraph 12 by the following paragraph:

“12. Iberville, Chief Place: Saint-Jean-sur-Richelieu.

The judicial district of Iberville comprises the territory bounded as follows: starting from the meeting point between the centre line of the Richelieu river and the extension of the dividing line between the cadastres of the parishes of Notre-Dame-de-Bonsecours and Saint-Athanase; thence, successively, the following lines: the said extension and the said dividing line between cadastres; a broken line dividing the cadastre of the parish of Saint-Grégoire from the cadastres of the parishes of Notre-Dame-de-Bonsecours, Sainte-Marie-de-Monnoir and Sainte-Angèle; part of the dividing line between the cadastres of the parishes of Sainte-Angèle and Sainte-Brigide; in the cadastre of the parish of Sainte-Brigide, the centre line of a road bounding on the northeast lots 215, 216, 245, 244 and 243; the north line of lot 449; the northeast line of lots 449, 450 and 451; part of the east limit of the said cadastre; the northeast line of lots 506 and 377; part of the east line of lot 315 and the east line of lots 316 to 322; part of the dividing line between lots 325 and 368; the east line of lot 326; the southwest line of lots 326, 327 and 328; part of the east line of lot 329 and the southwest line of lots 329, 330 and 331; the west line of lots 332 and 333; part of the southwest line of lot 96; in the cadastre of the parish of Saint-Alexandre, the east line of lot 41; the southwest line of lots 41 and 40; the southeast line of lot 92; the northeast line of lots 209 to 225; the southeast line of lots 225 and 226; the northeast and east limits of the cadastre of the parish of Saint-Alexandre; the east limit of the cadastre of the parish of Saint-Sébastien; in that cadastre, part of the south line of lot 153; the east line of lots 179 and 345; the dividing line between lots 345 and 368; the northeast and west lines of lot 318; the south line of the cadastres of the parishes of Saint-Sébastien and Saint-Georges-d'Henryville extended to the centre line of the Richelieu river; the centre line of the said river upstream and running west of de l'Hôpital and Ash islands and continuing to the Québec/United States boundary line; the said boundary line westerly; part of the west limit of the cadastre of the parish of Lacolle; a broken line dividing the cadastre of the parish of Saint-Patrice-de-Sherrington from the cadastres of the township of Hemmingford and the parish of Saint-Jean-Chrysostome; the southwest limit of the cadastre of the parish of Saint-Michel-Archange; a broken line dividing the cadastre of the parish of Saint-Rémi from the cadastre of the parish of Saint-Michel-Archange; another broken line dividing the cadastres of the parishes of Saint-Michel-Archange, Saint-Édouard and Saint-Jacques-le-

Mineur from the cadastres of the parishes of Saint-Constant and Saint-Philippe; another broken line dividing the cadastres of the parishes of Saint-Philippe and Laprairie de La Madeleine from the cadastres of the parishes of Sainte-Marguerite-de-Blairfindie and Saint-Luc; the dividing line between the cadastres of the parishes of Saint-Joseph-de-Chambly and Saint-Luc, the last segment of that line extended to the centre line of the Richelieu river; finally, the centre line of the said river downstream to the starting point.

This judicial district includes the following municipalities: the towns of Iberville, Saint-Jean-sur-Richelieu and Saint-Luc; the villages of Henryville, Lacolle, Mont-Saint-Grégoire, Napierville and Saint-Alexandre; the parish municipalities of Notre-Dame-du-Mont-Carmel, Saint-Alexandre, Sainte-Anne-de-Sabrevois, Saint-Athanase, Saint-Bernard-de-Lacolle, Saint-Blaise, Saint-Cyprien, Saint-Édouard, Saint-Grégoire-le-Grand, Saint-Jacques-le-Mineur, Saint-Michel, Saint-Patrice-de-Sherrington, Saint-Paul-de-l'Île-aux-Noix, Saint-Sébastien and Saint-Valentin; the municipalities of Henryville and Lacadie; the municipality of Sainte-Brigide-d'Iberville less that part comprised in the township of Farnham; that part of the city of Farnham comprised in the cadastre of the parish of Sainte-Brigide and that part of the municipality of Saint-Mathieu comprised in the cadastre of the parish of Saint-Édouard.”;

(h) by striking out, from the second paragraph of the description of the judicial district of Joliette (paragraph 13), the word “Maskinongé” in the ninth line, the words “Saint-Joseph de Maskinongé” in the thirty-second and thirty-third lines and the words “Saint-Justin” in the thirty-third and thirty-fourth lines.

(i) by inserting, after paragraph 15, the following paragraph:

“15a. Laval, Chief Place: Laval.

The judicial district of Laval comprises the territory bounded as follows: starting from the point of intersection between the centre line of the railway right of way of Canadian Pacific Railways (lot 676 of the cadastre of the parish of Saint-Martin) and the centre line of the des Prairies river; thence, successively, the following lines and boundaries: the said centre line of the des Prairies river downstream, running northwest of La Visitation island and the islands bearing numbers 503, 492 and 491 of the cadastre of the parish of Sault-au-Récollet and southeast of the islands bearing numbers 193 to 200 inclusively of the cadastre of the parish of Saint-François-de-Sales, to its meeting point with the centre line of the Mille-Iles river; the centre line of the said river upstream, running northwest of the islands bearing num-

bers 201, 202, 204, 207 and 212 of the cadastre of the parish of Saint-François-de-Sales, the islands bearing numbers 597 to 601 inclusively and 616 of the cadastre of the parish of Saint-Louis-de-Terrebonne, west of all the islands forming part of the cadastre of the parish of Sainte-Rose and southwest of the island bearing number 235 of the cadastre of the parish of Sainte-Dorothée, to the centre line of the des Prairies river; the centre line of the des Prairies river downstream, running south of the islands bearing numbers 236 and 241 of the cadastre of the parish of Sainte-Dorothée, southeast of the islands bearing numbers 239, 238, 237 and 240 of the said cadastre, northwest of the island bearing numbers 2632, 2633 and 2634 of the cadastre of the parish of Saint-Laurent, southeast of the island bearing number 678 of the cadastre of the parish of Saint-Martin and continuing to the starting point.

This judicial district comprises the city of Laval.”;

“15b. Longueuil, Chief Place: Longueuil.
