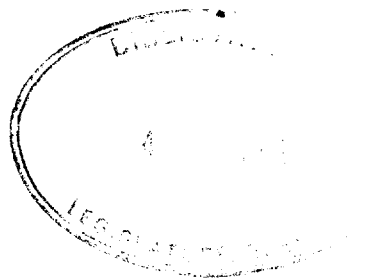

An Act respecting the town of Gagnon

WHEREAS it is in the interest of the town of Gagnon that its territory be extended;

HER MAJESTY, with the advice and consent of the Assemblée nationale du Québec, enacts as follows:

1. The following territory is annexed to that of the town of Gagnon:

A territory situated in the townships of Roz, Boucault, Thury, Malapart, Bergeron, Surveyer, Claudel, Beaudoin, Cabanac, Hind, Clément, Laussedat, Tilly, Noré, Racicot, Chiasson, Conan, Hesry, Leventoux, Bélanger, Berthelet, Godefroy, Fagundez, Le Courtois and Nadeau, and not presently a part of any separate local municipality in the municipal county of Saguenay and comprising, with reference to the original survey or to the cadastres of the said townships, as the case may be, all the lots or parts of lots and the blocks or parts of blocks and their present and future subdivisions and the roads, highways, railway rights of way, islands, lakes and watercourses, or parts thereof, the whole comprised within the two perimeters hereinafter described, to wit:

INTERIOR PERIMETER:

Following the present limits of the town of Gagnon, starting from boundary marker number 9 of the dividing line between the townships of Conan and Chiasson; thence, successively, the following lines and boundaries; in an astronomic westerly direction, a straight line for a distance of two miles (2 mi or 3,22 km); in an astronomic northerly direction, a straight line for a distance of three hundred and twenty and one hundredth chains (320.01 ch or 6 437,6 m); in an astronomic easterly direction, a straight line

to the dividing line between the townships of Chiasson and Conan; finally, part of the said dividing line between townships, south-erly, to the starting point;

EXTERIOR PERIMETER:

Starting from the northeast corner of the township of Bergeron; thence, successively, the following lines and boundaries: the east line of the townships of Bergeron, Hind, Racicot, Bélanger and Nadeau; the south line of the townships of Nadeau, Le Courtois, Fagundez, Godefroy and Berthelet; the west line of the townships of Berthelet, Chiasson, Clément, Surveyer and Roz; finally, the north line of the townships of Roz, Boucault, Thury, Malapart and Bergeron to the starting point; these east, south, west and north lines joined one to the other by sections of the dividing line between townships and extended across the lakes and watercourses that it meets.

The territory included within the two perimeters described above to be annexed to the town of Gagnon.

- 2.** This act comes into force on the day of its sanction.
