# ADDITIONAL EFFORTS TO PREPARE FOR THE FUTURE

The Budget 2021-2022 provides for nearly \$15 billion in additional initiatives by 2025-2026, including \$5.2 billion starting this year to:

- Strengthen our health care system
- Support educational success and young people
- Accelerate growth and the transition to the new economy
- Support Quebecers

## STRENGTHENING OUR HEALTH CARE SYSTEM

An additional **\$7 billion**  
to overcome the public health crisis

- To improve health care in a long-lasting manner

# Strengthening services for seniors

- More resources to provide services tailored to needs

- An assistance program to bring some residences up to standard

to enhance the refundable tax credit for home-support services for seniors

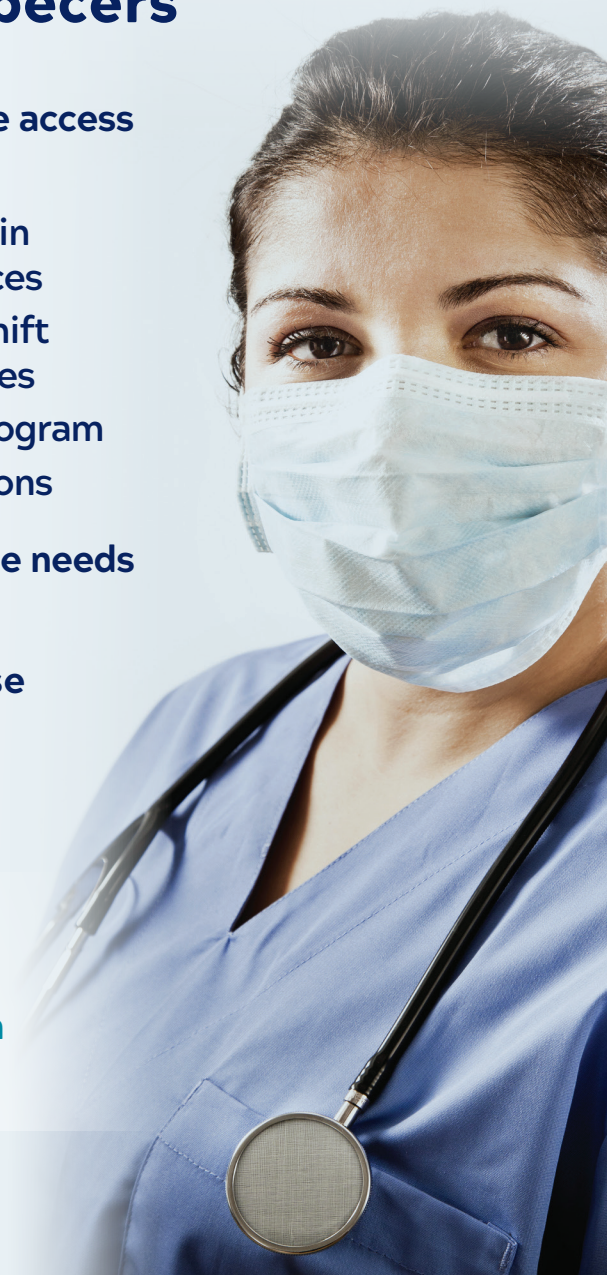

## Facilitating the social and professional integration of young people

## Supporting the requalification of workers and getting them back into the labour market

**\$46 million** to increase labour market participation through graduation



## Continuing to support businesses affected by the pandemic

- Maintaining the Concerted Temporary Action Program for Businesses (PACTE) and the Emergency Assistance Program for Small and Medium-Sized Businesses (PAUPME)
- Extending the tax credit in respect of employer contributions to the Health Services Fund for employees on paid leave

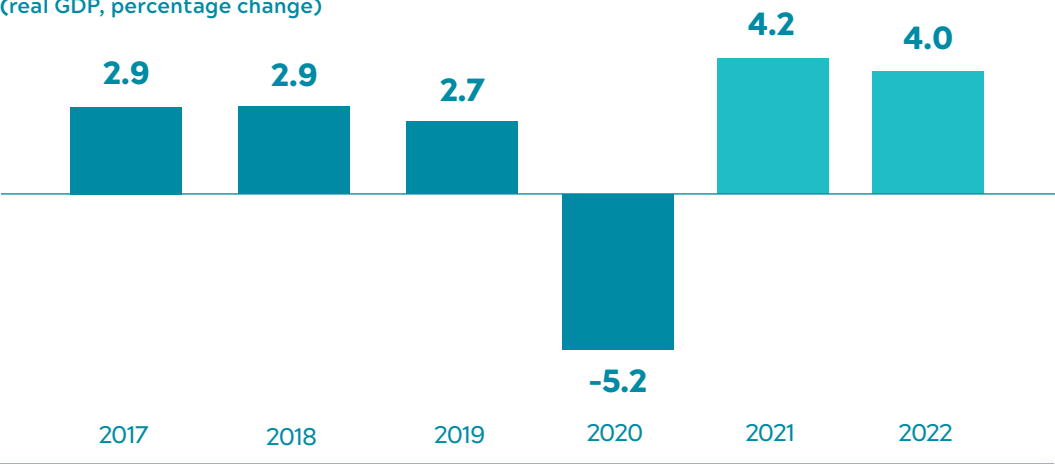


# THE ECONOMY RESTART HAS BEGUN

## A strong economic recovery is expected in the coming years

- A return to pre-pandemic levels of economic activity is anticipated by the end of 2021

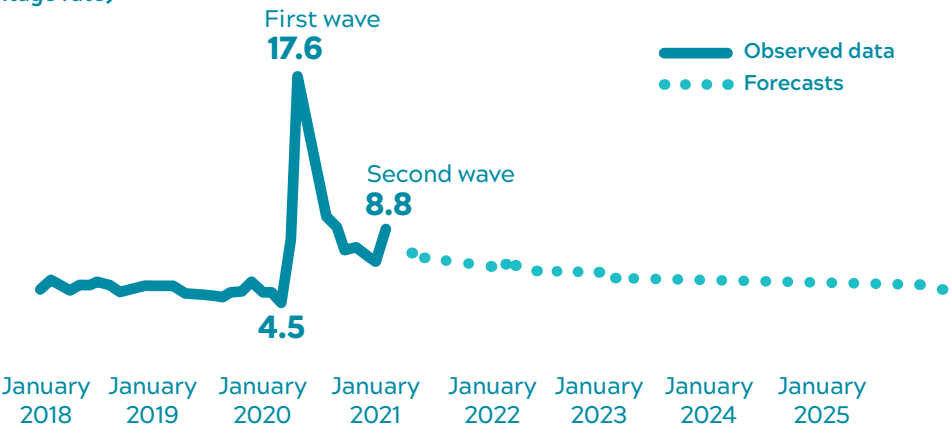
ECONOMIC GROWTH IN QUÉBEC

# A RETURN TO FISCAL BALANCE WITHIN 7 YEARS

The support measures implemented by the government and the resilience of the Québec economy have limited the deterioration of public finances.

The deficit will reach \$12.3 billion in 2021-2022 and drop to \$8.5 billion in 2022-2023.

No budgetary deficit offsetting measures will be implemented until Québec's rate of employment returns to its pre-pandemic level.

Fiscal balance is expected to be restored in 2027-2028.

The plan to return to fiscal balance will be based on the following principles:

- The government's commitment not to increase the tax burden
- Expenditure growth in line with revenue growth
- The acceleration of economic growth
- An increased federal contribution to health costs

## Debt under control
