CHAP. 25

An Act to incorporate the Montreal Technical School

[Assented to 14th March, 1907]

Preamble.

WHEREAS it is desirable for the needs of trade and industry in this Province, to prepare, by means of practical and technical studies, young men who intend to devote themselves to industrial careers and, by means of adequate instruction capable of training them in a practical manner, to develop in them a sufficient knowledge of mechanical trades and of industry generally ;

Whereas a technical school in Montreal, founded for the object aforesaid, would turn out manufacturers and workmen possessing sufficient theoretical knowledge and trained in practical shop work ;

Whereas it is expedient to constitute a corporation for the purpose of assuring to such school all the advantages that may be secured for it by the Government of this Province, by the city of Montreal and by private individuals ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Name of
corporation.
Its members.

1. A technical industrial school is incorporated in Montreal under the name of " The Montreal Technical School. "

The corporation shall consist ;

(a) Of a delegate appointed by the Montreal Board of Trade ;

(b) Of a delegate appointed by *la Chambre de Commerce* of the district of Montreal ;

(c) Of two delegates appointed by the council of the city of Montreal ;

(d) Of four delegates appointed by the Lieutenant-Governor in Council.

(e) Of the principal appointed under section 10.

2. Such delegates shall be appointed for three years by their respective principals. Their services shall be gratuitous. Delegates for how long appointed, &c.

3. 1. The institutions mentioned in section 1 of this act shall appoint their delegates within six months from the coming into force of this act. Date of appointment of certain delegates.

2. In default of any one of such institutions appointing its delegate or delegates within the delay above specified, or in default, thereafter, of a vacancy occurring among the members of the corporation being filled within the month following the occurrence of such vacancy, the Provincial Secretary may, *ex-officio*, make the necessary appointments. Appointment of delegates by Provincial Secretary in certain cases.

3. The delays mentioned in this section may, nevertheless, be extended by the Lieutenant-Governor in Council. Extension of delay to appoint.

4. 1. The members of the corporation shall each year choose from among their number a president and secretary-treasurer. These officers shall remain in office for one year or till the expiration of their mandate if they cease to be members of the corporation within a year from the time of their appointment. The president shall have a casting vote in all questions, when the votes are equally divided. President and secretary-treasurer. Their term of office, &c.

In the event of a vacancy, the president and secretary-treasurer shall be replaced, but their successors shall be elected only for the unexpired terms of the officers whom they replace respectively. How replaced, &c.

2. The signatures of the president and secretary-treasurer shall suffice in all legal matters of the corporation. They sign for the corporation.

5. For the purpose of assuring the construction of a suitable building for the technical school at Montreal, and of enabling it to procure libraries, laboratories, workshops and the necessary appliances and apparatus, the corporation of the technical school is hereby authorized to contract a loan or loans not exceeding two hundred thousand dollars in all, by means of debentures payable in the manner, at the times and places, and at the rate of interest determined by it, and guaranteed as to principal and interest by the Government of the Province. Loans for certain purposes. Debentures therefor and guarantee thereof.

6. The Lieutenant-Governor in Council is authorized to guarantee the payment of the principal and interest of the loan or loans, not exceeding in all two hundred thousand dollars, mentioned in the foregoing article, on such conditions as he may deem expedient. Lieutenant-Governor in Council may guarantee loans.

7. With the view of aiding the school established by this act and of acknowledging the services it will be called upon to render to the Province, it shall be lawful for the Lieute- Annual grant of \$10,000.

nant-Governor in council to allow the said school an annual sum of ten thousand dollars.

Annual grant of \$15,000 by city of Montreal, &c. **8.** Likewise, with the view of aiding such school, the city of Montreal is authorized to subscribe and to borrow for such purpose, if necessary, and it undertakes to pay, a yearly amount of fifteen thousand dollars.

Grants how employed. **9.** The sums subscribed and paid by the Government of the Province and by the city of Montreal, shall be first employed in paying the interest and sinking fund of the loan or loans, and the remainder shall be employed for the needs of the school generally.

Principal, his appointment and duties. **10.** The principal of the school shall be appointed by the Lieutenant-Governor in Council on the recommendation of the corporation. He shall be *de jure* a member of the corporation, and be specially charged, under the control of the administrative commission, and of the corporation, with the direction of the studies, the maintenance of order and discipline and, generally, with everything concerning the internal management of the school.

Acquisition of property, &c. **11.** The corporation shall have the right to acquire moveable and immoveable property, by donation, legacy and purchase, and to perform all acts of ownership in connection therewith.

General powers. **12.** The corporation may also sue and be sued, borrow, sign, endorse, accept and negotiate promissory notes, bills of exchange and other commercial instruments, and become a party thereto under any title whatsoever, and shall, moreover, possess all the right and powers belonging generally to corporations, in so far as the present act does not derogate therefrom.

Property, &c, how to be used. **13.** All property to be acquired and all revenues arising therefrom, shall be the exclusive property of the corporation, and shall be used solely for the purposes of the said corporation.

Limit of value of immoveables. **14.** The net revenue of the immoveable property belonging to the corporation held for purposes of revenue, shall not exceed twenty-five thousand dollars yearly.

Regulations. **15.** The corporation of the technical school have power to make regulations :

1. To define the duties and functions of the professors and employees and to fix their salaries ;

2. For the administration of the school, the conduct of the students and the school fees payable by them ;

3. To establish a course of study in conformity with the spirit of this act.

4. To determine the number of years of study ;

5. To determine the conditions of admission and examination.

6. For the proper management of the affairs of the corporation generally and for the proper working of the school ;

Such regulations shall not, however, go into operation until sanctioned by the Lieutenant-Governor in Council. Sanction by
Lieutenant-
Governor, &c.

16. The professors shall be appointed by the Provincial Secretary, on the advice of the members of the corporation, expressed by the majority of the votes of the members present at a meeting convened for the purpose. Professors
how appoint-
ed.

17. The professors of the school may be removed for cause by the Provincial Secretary on the advice expressed by the vote of two-thirds of all the members of the corporation. Removal of
Professors.

18. The quorum at meetings of the corporation shall be five members. Quorum at
meetings.

19. The carrying out of the regulations adopted by the corporation, shall be entrusted to an administrative committee consisting of the principal and of two members appointed by the corporation. Administra-
tive commit-
tee.

The administrative committee shall render an account of its administration to the corporation and to the Lieutenant-Governor in council, yearly, or oftener if thereunto required. Accounts
which it
renders.

20. A council of improvement, presided over by the principal and consisting of all the members of the staff of professors, shall see to the measures to be taken in the interest of the studies, and submit propositions to the administrative committee. It shall meet at least three times a year. Council of
improvement

21. The corporation shall have the right to establish branches within the limits of the Province and to make any regulations it may deem expedient for the proper management of such branches. Branches of
corporation,
&c.

22. The corporation shall have the right to expropriate all lands and buildings the expropriation of which may be deemed necessary for the purposes of this act. Expropria-
tion, &c.

Diplomas to students.

23. The corporation shall deliver diplomas to the students according to the special course followed by each of them.

What diplomas to contain.

Mention shall be made in the diploma that the student has undergone his examinations during the course in a satisfactory manner, or with distinction, or with great distinction, or with the greatest distinction, according to the disciplinary rules of the school.

Diplomas how signed, &c.

Such diploma shall be signed by the principal of the school and be countersigned by the Provincial Secretary.

Jury to examine students, &c.

24. A jury, consisting of seven members, appointed by the Provincial Secretary, upon the recommendation of the corporation, assisted by the principal and by two professors of the school, designated by the principal, shall be appointed to examine the students who, on the completion of their studies, wish to obtain a diploma of competency.

CHAP. 26

An Act respecting the McGill Normal School, and to ratify and confirm an agreement between His Majesty the King, in right of the Province of Quebec and the Royal Institution for the Advancement of Learning and for other purposes.

[Assented to 14th March, 1907]

Preamble.

WHIEREAS by private writing executed at the cities of Quebec and Montreal, on the 25th and 26th days of February, 1907, and hereunto annexed as a schedule hereto, an agreement was entered into between His Majesty the King, in right of the Province of Quebec, of the one part, and the Royal Institution for the Advancement of Learning, a body politic and corporate, having its chief office and principal place of business at the city of Montreal, of the other part, whereby it was, among other things, provided that the McGill Normal School, which has, for many years past, been carried on in the city of Montreal upon property belonging to the Crown in the right of the Province, should cease to be so carried on, and that in lieu thereof, there should be established and carried on, under the regulations of the Protestant Committee of
