CHAPTER 22

An Act to amend the Act respecting the provisional administration of the Parity Committee for the Flat Glass Industry and the Corporation de formation des vitriers et travailleurs du verre du Québec

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

1. Section 3 of the Act respecting the provisional administration of the Parity Committee for the Flat Glass Industry and the Corporation de formation des vitriers et travailleurs du verre du Québec (1994, chapter 9) is replaced by the following section:

Powers and
functions

“3. For the duration of the suspension, the powers and functions of the Parity Committee and of the persons referred to in the first paragraph of section 2 shall be exercised, for and on behalf of the Parity Committee, by three persons designated by the Minister of Employment, or by their replacements. These persons constitute the provisional administrator within the meaning of this Act.

Term of
office

A person designated under the first paragraph shall remain in office until the end of the provisional administration or until replaced by the Minister of Employment.

Personnel

The Minister of Employment may assign to the provisional administrator such personnel as he considers necessary.”

2. Section 20 of the said Act is amended by replacing the words “Commission or its chairman” in the fourth line by the words “Minister of Employment”.

Term of
office

3. A person having been designated under the first paragraph of section 3 of the Act respecting the provisional administration of the Parity Committee for the Flat Glass Industry and the Corporation

de formation des vitriers et travailleurs du verre du Québec, or a member of the personnel having been assigned to the provisional administrator under the third paragraph of the said section shall remain in office until the end of the provisional administration or until replaced by the Minister of Employment.

Coming into
force

4. This Act comes into force on 12 June 1995.
