CHAPTER 1

Appropriation Act No. 1, 1994-95

[Assented to 31 March 1994]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$8 000 360 572.00
for 1994-95

1. The Government may draw out of the consolidated revenue fund a sum not exceeding \$8 000 360 572.00 to defray a part of the expenditure estimates of Québec tabled in the National Assembly for the fiscal year 1994-95, not otherwise provided for.

Apportion-
ment

That sum is apportioned according to the amounts shown in the Schedule for the various programs listed therein, constituted as follows:

(1) \$7 842 228 750.00, being 25.0 % of the appropriations to be voted for each of the programs appearing in the expenditure estimates of the Government for the said fiscal year;

(2) \$784 900.00, being an additional 2.7 % of the appropriations to be voted for Program 1, "Municipal Development", of the Ministère des Affaires municipales;

(3) \$21 624 300.00, being an additional 25.8 % of the appropriations to be voted for Program 2, "Administrative and Financial Assistance and Supervision", of the Ministère des Affaires municipales;

(4) \$31 518 200.00, being an additional 12.2 % of the appropriations to be voted for Program 5, "Financial Compensation", of the Ministère des Affaires municipales;

(5) \$7 901 600.00, being an additional 15.5 % of the appropriations to be voted for Program 7, "Development of Recreation, Sport and Outdoor Activities", of the Ministère des Affaires municipales;

(6) \$12 868 100.00, being an additional 18.3 % of the appropriations to be voted for Program 2, "Farm Financing", of the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation;

(7) \$7 631 065.00, being an additional 4.0 % of the appropriations to be voted for Program 4, "Advisory Bodies and Government Corporations", of the Ministère de la Culture et des Communications;

(8) \$509 800.00, being an additional 0.9 % of the appropriations to be voted for Program 3, "Support for Government Corporations and Agencies", of the Ministère de l'Industrie, du Commerce, de la Science et de la Technologie;

(9) \$686 500.00, being an additional 16.0 % of the appropriations to be voted for Program 4, "Forestry Financing", of the Ministère des Ressources naturelles;

(10) \$7 097 325.00, being an additional 63.3 % of the appropriations to be voted for Program 2, "Parental Wage Assistance Program", of the Ministère du Revenu;

(11) \$3 184 415.00, being an additional 65.0 % of the appropriations to be voted for Program 3, "Administration and Management of the Commission des affaires sociales", of the Ministère de la Sécurité du revenu;

(12) \$34 923 950.00, being an additional 0.9 % of the appropriations to be voted for Program 4, "Income Security", of the Ministère de la Sécurité du revenu;

(13) \$8 250 000.00, being an additional 2.1 % of the appropriations to be voted for Program 1, "Land Transportation Systems", of the Ministère des Transports;

(14) \$21 151 667.00, being an additional 5.0 % of the appropriations to be voted for Program 6, "School Transportation", of the Ministère des Transports.

Special warrant No. 1
1993-94

2. Notwithstanding section 43 of the Financial Administration Act (R.S.Q., chapter A-6), the special warrant No. 1 1993-94, issued on 16 March 1994 for the requirements of the Work and Employment Incentives Program, Financial Support Program and Income Security for Cree Hunters and Trappers Program of the Ministère de la Sécurité du revenu, is an appropriation for the fiscal year 1994-95 included in the budget estimates for that fiscal year submitted to the National Assembly and constitutes an expenditure for that fiscal year.
