## CHAPTER 7

### Appropriation Act No. 2, 1994-95

[Assented to 26 May 1994]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$23 078 254 428.00  
for 1994-95

**1.** The Government may take out of the consolidated revenue fund a sum not exceeding \$23 078 254 428.00 to defray a part of the expenses of Québec proposed in the estimates for the fiscal year 1994-95 as laid before the National Assembly, not otherwise provided for, being the amount of the appropriations to be voted for each of the various programs listed in the Schedule less the amounts of the appropriations appearing in the special warrant No. 1 1993-94 (\$290 300 000.00) applicable to the fiscal year 1994-95 in accordance with section 2 of the Appropriation Act No. 1, 1994-95, and the amounts of the other appropriations appearing in the Appropriation Act No. 1, 1994-95 (\$8 000 360 572.00).
