CHAPTER 58

An Act respecting the cities and towns of Anjou, Montréal, Montréal-Est and Montréal-Nord

[Assented to 17 June 1994]

Preamble

WHEREAS it is in the interest of the cities and towns of Anjou, Montréal and Montréal-Est that their territorial limits be rectified;

Whereas it is in the interest of those cities and towns and Ville de Montréal-Nord that Ville de Montréal be empowered to exercise certain powers over part of their territories;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

Territory
detached

1. The territory described in Schedule I is detached from the territory of Ville d'Anjou and attached to the territory of Ville de Montréal. The territory described in Schedule II is detached from the territory of Ville de Montréal and attached to the territory of Ville d'Anjou.

Payment

Ville de Montréal shall pay an amount of \$1 894 600 to Ville d'Anjou.

detached

2. The territory described in Schedule III is detached from the territory of Ville de Montréal-Est and attached to the territory of Ville de Montréal. The territory described in Schedule IV is detached from the territory of Ville de Montréal and attached to the territory of Ville de Montréal-Est.

Payment

Ville de Montréal shall pay an amount of \$150 000 to Ville de Montréal-Est.

Applicabil-
ity of provi-
sions

3. Sections 168 to 175 of the Act respecting municipal territorial organization (R.S.Q., chapter O-9), adapted as required, apply to the territories annexed under sections 1 and 2.

Jurisdiction

4. Notwithstanding any inconsistent provision, the parts of the territories of the cities and towns of Anjou, Montréal-Est and Montréal-Nord which form the right of way of Henri-Bourassa boulevard between autoroute 40 and Langelier boulevard, as well as all the lands contiguous to that right of way shall be, for the purposes of paragraph 10 of article 523 and articles 571 to 607 of the charter of the city of Montréal (1959-60, chapter 102), subject to the jurisdiction of The Electrical Commission of the City of Montréal established under article 571 of that charter.

Cost of con-
duits

However, the cost of the conduits constructed under article 591 of that charter shall, beyond five metres from the street line, be assumed by the cities or towns in whose territories they are constructed. Ville de Montréal may require those cities or towns to provide prior deposit of a sum sufficient to guarantee the payment of the cost of the work chargeable to them.

Approval

5. Notwithstanding section 556 of the Cities and Towns Act (R.S.Q., chapter C-19), any loan by-law of the cities and towns of Anjou, Montréal-Est and Montréal-Nord for the payment to Ville de Montréal of a sum owing under an intermunicipal agreement entered into between those four cities and towns in relation to the reconstruction of the part of Henri-Bourassa boulevard referred to in section 4 requires only the approval of the Minister of Municipal Affairs.

6. This Act comes into force on 17 June 1994, except sections 1 and 2 which come into force on 31 December 1994.

(3) a certain parcel of territory of irregular shape made up of part of original lots 448 (four parts), 449 (three parts), 451 (three parts), 452 (five parts), 453 (five parts), 473, 475, 477 (four parts), 478 (two parts) and 479 and of lots 448-359, 448-360, 448-361, 448-362, 448-363 and 448-364 of the cadastre of the parish of Longue-Pointe, containing an area of eighty-three thousand five hundred and eighty four and five tenths square metres (83 584.5 m²) and indicated by the letters Q'R'S'T'U'V'W'X'Y'Z'A"B"C"D'Q'.

(2) a certain parcel of territory of irregular shape made up of part of original lots 136, 137 (two parts), 140 (two parts), 141 (two parts), 142 (two parts), 143 (two parts), 144 (two parts), 150 (two parts), 151, 152 and 159 (two parts), of part of lots 137-298, 137-300, 137-304, 137-306, 137-584, 137-586, 137-588, 137-590, 137-591, 137-1004, 137-1006 (two parts), 137-1138, 137-1167, 137-1168, 137-1178, 160-1089, 160-1090 (two parts), 160-1091 (street), 160-1126, 160-1127, 160-1156, 160-1157 (street) and 160-1190 and of lots 137-299, 137-305, 137-585, 137-589, 137-1005 and 137-2152 of the cadastre of the parish of Rivière-des-Prairies, containing an area of twenty-four thousand five hundred and ninety-six and nine tenths square metres (24 596.9 m²) and indicated by the letters ZB'C'D'E'F'G'H'J'K'L'M'N'P'Q'Z.
