THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

1. The Government may take out of the consolidated revenue fund a sum not exceeding \$20 469 088 150.00 to defray a part of the expenses of Québec proposed in the estimates for the fiscal year 1992-93 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule, less the amounts voted under the Appropriation Act No. 1, 1992-93 (\$282 668 750.00) and the Appropriation Act No. 2, 1992-93 (\$9 776 305 700.00).
