## CHAPTER 101

### **An Act to amend the Act respecting The Québec Federation of Catholic School Commissions**

*[Assented to 21 May 1991]*

Preamble WHEREAS The Québec Federation of Catholic School Commissions was incorporated under chapter 140 of the statutes of 1960-61;

Whereas it is expedient to enable the federation to accept as member any school board of the province of Québec without reference to confessional or linguistic status;

Whereas it is expedient that the name of The Québec Federation of Catholic School Commissions be replaced by that of the Fédération des commissions scolaires du Québec;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** Section 2 of the Act respecting The Québec Federation of Catholic School Commissions (1960-61, chapter 140), amended by section 1 of chapter 102 of the statutes of 1969 and by section 1 of chapter 102 of the statutes of 1974, is again amended by replacing paragraph 3 by the following paragraph:

“School  
board”

“3. “School board” means any school board governed by the Education Act (R.S.Q., chapter I-13.3) or by the Education Act for Cree, Inuit and Naskapi Native Persons (R.S.Q., chapter I-14).”

**2.** Section 6 of the said Act, amended by section 2 of chapter 102 of the statutes of 1969, is again amended by striking out the fourth paragraph.

**3.** Section 8 of the said Act, replaced by section 3 of chapter 102 of the statutes of 1969 and amended by section 3 of chapter 102 of the statutes of 1974, is replaced by the following section:

Object

**“3.** The object of the federation is to promote the interests of education and, for such purpose, to:

- (1) group and unite the school boards of the province of Québec;
- (2) take any action calculated to defend and protect the interests of its members and all of the school boards of the province of Québec;
- (3) assist in settling the various educational, cultural, economic and social problems which may arise with respect to its members.”

**4.** The said Act is amended by striking out the word “Catholic” wherever it appears, except in section 4.

**5.** The title of the said Act is replaced by the following title:

**“An Act respecting the Fédération des commissions scolaires du Québec”.**
