CHAPTER 17

An Act to change the name of the Corporation professionnelle des comptables en administration industrielle du Québec and the title of its members

[Assented to 15 April 1987]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

c. C-26,
s. 36, am. **1.** Section 36 of the Professional Code (R.S.Q., chapter C-26) is amended by replacing paragraph *a* by the following paragraph:

“(a) use the title “comptable en management accrédité” in French or “Certified Management Accountant” in English or any title comprising such expression or the equivalent, or use the initials “C.M.A.” unless he holds a valid permit for that purpose and is entered on the roll of the Corporation professionnelle des comptables en management accrédités du Québec;”.

s. 37, am. **2.** Section 37 of the said Code is amended by replacing paragraph *a* by the following paragraph:

“(a) the Corporation professionnelle des comptables en management accrédités du Québec: establish cost accounting and do cost accounting and business organization and management;”.

c. C-26,
Sched. I, am. **3.** Schedule I to the said Code is amended by replacing paragraph 22 by the following paragraph:

“22. The Corporation professionnelle des comptables en management accrédités du Québec;”.

No effect on
rights **4.** The change in the name of the professional corporation does not affect in any way the corporation's rights and obligations.

5. Section 28 of the Chartered Accountants Act (R.S.Q., chapter C-48) is amended by replacing the words “comptables en administration industrielle” in the second line of the first paragraph by the words “comptables en management accrédités”.

Expressions
replaced

6. In any regulation, by-law, proclamation, order in council, order, contract or other document, the expression “Corporation professionnelle des comptables en administration industrielle du Québec” is replaced by the expression “Corporation professionnelle des comptables en management accrédités du Québec” and the expression “Registered Industrial Accountant” is replaced by the expression “Certified Management Accountant”, adapted as required.

Prohibited
title

7. No person may use the title “Registered Industrial Accountant” or any title comprising such expression or the equivalent or use the initials “R.I.A.”

Applicable
provisions

Chapter VII of the Professional Code, adapted as required, applies to offences under this section.

Coming into
force

8. This Act comes into force on 15 April 1987.
