CHAPTER 32

Appropriation Act No. 3, 1987-88

[Assented to 18 June 1987]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$16 464 827
825.01
for 1987-88

1. The Government may take out of the consolidated revenue fund a sum not exceeding \$16 464 827 825.01 to defray a part of the expenses of Québec proposed in the estimates for the fiscal year 1987-88 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule, less the amounts voted under the Appropriation Act No. 1, 1987-88 (\$362 024 250.00) and under the Appropriation Act No. 2, 1987-88 (\$5 591 347 024.99).
