## CHAPTER 45

### **An Act to amend the Act respecting the Ministère des Communications**

*[Assented to 23 June 1987]*

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** Section 3 of the Act respecting the Ministère des Communications (R.S.Q., chapter M-24) is amended by replacing subparagraph *d* of the first paragraph by the following subparagraphs:

“(d) establish communications services for all government departments;

“(d.1) supply, for a consideration, telecommunications services to the departments, except services designated by the Government for the departments it determines;

“(d.2) supply, on request and for a consideration, telecommunications services to public bodies or other bodies defined by the Government;

“(d.3) supply, on request and for a consideration, computer services to the departments and to public bodies or other bodies defined by the Government;

“(d.4) ensure coordination of communications services established by public bodies, municipal corporations and any urban or regional community with the services established by him;”.

**2.** The said Act is amended by inserting, after section 19, the following chapter:

## "CHAPTER III

## "SERVICE FUNDS

Establishment

**"19.1** Two special funds hereinafter called "telecommunications services fund" and "computer services fund" are hereby established.

Amounts put into the funds

**"19.2** The following amounts shall be paid into the funds:

(1) the sums received as remuneration for services financed through the funds;

(2) the proceeds from advances that may be granted to them by the Minister of Finance out of the consolidated revenue fund with the authorization of the Government;

(3) the sums that may be deposited in the funds by the Minister out of the appropriations allocated for that purpose by Parliament.

Use of funds

**"19.3** The funds shall be assigned to, respectively, the financing of the costs of telecommunications services and computer services supplied by the Minister in accordance with subparagraphs *d.1*, *d.2* and *d.3* of the first paragraph of section 3.

Management

**"19.4** The sums deposited in the funds shall be managed by the Minister of Finance. They shall be credited to him and deposited with the financial institutions he determines.

Bookkeeping

The books of account for the funds shall be kept by the Ministère des Communications.

Use of funds

**"19.5** For each fund, the Government shall determine the date on which operations are to begin, the assets and liabilities to be posted, the nature of the services and costs that may be paid for or assumed by the fund and the surpluses to be remitted to the consolidated revenue fund.

Applicable provisions

**"19.6** The sums deposited in the funds are subject to sections 22, 23, 25 to 27, 33, 35, 45, 48, 49, 51, 57, 70, 71 and 72 of the Financial Administration Act (R.S.Q., chapter A-6), adapted as required.

Terms replaced

For the purposes of section 51 of the said Act, the terms "consolidated revenue fund" are replaced by the terms "telecommunications services fund" or "computer services fund", as the case may be.

Employees

**"19.7** The sums necessary for the payment of the remuneration and expenses pertaining to social benefits and other conditions of

employment of the persons assigned, in accordance with the Public Service Act (R.S.Q., chapter F-3.1.1), to activities related to the telecommunications services fund and to the computer services fund shall be taken out of those funds.

Advances      “**19.8** Advances referred to in paragraph 2 of section 19.2 shall be repayable out of the fund in which the proceeds have been deposited.

Fiscal year      “**19.9** The fiscal year of the funds shall begin on 1 April in one year and end on 31 March in the following year.”

Transfer of appropriations      **3.** The appropriations allocated to the Ministère des Communications to defray the cost of telecommunications services and computer services for the fiscal year in which the operations of a fund begin shall be transferred to the departments and public bodies benefiting from the services, on the dates on which the operations of the funds begin, to the extent determined by the Government.

Transfer of appropriations      **4.** The appropriations allocated to the Office des ressources humaines to defray the employer's contributions for the fiscal year in which the operations of a fund begin shall be transferred to the departments and public bodies benefiting from the services, on the dates on which the operations of the funds begin, to the extent determined by the Government.

Coming into force      **5.** This Act comes into force on 23 June 1987.
