## CHAPTER 52

### **An Act to amend the Territorial Division Act with respect to certain registration divisions**

*[Assented to 23 June 1987]*

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

s. 11, am.

**1.** Section 11 of the Territorial Division Act (R.S.Q., chapter D-11), amended by section 4 of chapter 62 of the statutes of 1986, is again amended

(1) by adding, at the end of paragraph 3, the following subparagraph:

“(5) Notwithstanding subparagraph 4, that part of the township of Halifax, the municipality of the village of Saint-Sylvestre, the municipality of the parish of Saint-Sylvestre and that part of the parish of Saint-Patrice-de-Beaurivage which were included in the registration division of Mégantic as it existed on 19 June 1986 do not form part of the registration division of Arthabaska.”;

(2) by adding, at the end of paragraph 19, the following subparagraph:

“(3) The townships of Dudswell and Weedon and the villages of Lac-Weedon, Marbleton and Weedon-Centre, which were included in the registration division of Wolfe as it existed on 19 June 1986.”;

(3) by adding, at the end of paragraph 60, the following paragraph;

“Notwithstanding the foregoing, the townships of Dudswell, Garthby, Stratford, Weedon and Wolfestown and the villages of Beaulac, Lac-Weedon, Marbleton and Weedon-Centre, which were included in

the registration division of Wolfe as it existed on 19 June 1986, do not form part of the registration division of Richmond.”;

(4) by adding, at the end of paragraph 76, the following paragraphs:

“That part of the township of Halifax, the municipality of the village of Saint-Sylvestre, the municipality of the parish of Saint-Sylvestre and that part of the parish of Saint-Patrice-de-Beaurivage which were included in the registration division of Mégantic as it existed on 19 June 1986.

The townships of Garthby, Stratford and Wolfestown and the village of Beaulac which were included in the registration division of Wolfe as it existed on 19 June 1986.”

**2.** The provisions of this Act will come into force on the date or dates fixed by the Government.
