## CHAPTER 122

### An Act respecting the city of Drummondville

[Assented to 15 April 1987]

**Preamble** WHEREAS it is in the interest of the city of Drummondville that certain powers be granted to it;

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**Repeal** 1. The third paragraph of paragraph 13 of the letters patent amalgamating the city of Drummondville and the village of Drummondville-Ouest, published on 12 November 1966 in the *Gazette officielle du Québec* (page 5843), is repealed.

**Amendment to by-laws** 2. The by-laws of the city of Drummondville as listed in numerical order in Schedule A to this Act are amended by replacing the clauses respecting the apportionment of charges and the imposition of a special tax in every section indicated opposite each by-law by the following clause:

**Special tax** "By this by-law, a special tax shall be imposed and levied each year on all taxable immovables situated in the city at a sufficient rate according to the value of the immovables, as it appears on the assessment roll in force each year, to provide for the payment, in principal and interests, of the amounts due each year in accordance with the table annexed to the by-law."

**Title** 3. The title of the city of Drummondville or its representatives to the immovables of the cadastre of the township of Grantham, acquired by the city of Drummondville by deeds registered at the registry office

of the registration division of Drummond under the numbers listed in Schedule B and, as the case may be, transferred by the city by deeds registered at the said registry office under the numbers listed in Schedule C may not be contested on the ground that the city may not have complied with the formalities prescribed by law in respect of the acquisition or sale of the immovables or on the ground that the acquisition of all or part of the immovables may not have been effected by way of a loan by-law, but by means of sums of money deriving from the general fund of the city.

**4.** Upon payment of fees amounting to those that would be exigible for the registration of a judgment ordering the cancellation of the registration of the deeds registered under the numbers listed in Schedules B and C, the registrar of the registration division of Drummond shall enter, opposite such deeds, the mention "Confirmed by the Act registered under number . . .".

**5.** The registration of a true copy of this Act shall be effected by deposit.
