## CHAPTER 123

### **An Act respecting the city of Salaberry-de-Valleyfield**

*[Assented to 18 December 1987]*

Preamble

**WHEREAS** it is in the interest of the city of Salaberry-de-Valleyfield that it be granted certain powers;

**THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:**

Acquisition  
of immovables

**1.** The city is authorized to acquire the immovables described in the schedule.

Convention  
centre

**2.** The city is authorized to establish and operate a convention centre on the immovables referred to in section 1. It may also alienate or lease those immovables for commercial or housing purposes, or hold them for municipal purposes other than for the establishment and operation of a convention centre.

Administra-  
tion

**3.** The city may take over the administration of the convention centre or entrust it to any person, partnership or corporation and sign any agreement required for such purposes.

Coming into  
force

**4.** This Act comes into force on 18 December 1987.

Several parcels of land forming part of the cadastre of the city of Salaberry-de-Valleyfield, registration division of Beauharnois, situated in the city of Salaberry-de-Valleyfield, known and designated as being:

the unsubdivided part of original lot 755, subdivision number 1 of original lot 755 (755-1), subdivision number 2 of original lot 755 (755-2), part of original lot 829 B, part of original lot 829 C, part of original lot 829 D, original lot 829 E, the unsubdivided part of original lot 829 G, subdivision number 1 of original lot 829 G (829 G-1), original lot 830, original lot 830 A, original lot 830 B, original lot 830 C, original lot 830 D, original lot 830 E, the unsubdivided part of original lot 830 F, subdivision number 1 of original lot 830 F (830 F-1), original lot 830 G, original lot 831, original lot 832, original lot 833, the unsubdivided part of original lot 834, subdivision number 1 of original lot 834 (834-1), original lot 835, original lot 836, original lot 837, subdivision number 1 of original lot 845 (845-1), subdivision number 2 of original lot 845 (845-2), subdivision number 3 of original lot 845 (845-3), subdivision number 1 of original lot 846 (846-1), original lot 861, original lot 862, an unsubdivided part of original lot 863, a parcel of land without cadastral designation forming part of the bed of Saint-François bay, being du Centenaire street and, finally, another parcel of land without cadastral designation and forming part of the bed of the Saint-Charles river;

containing a total area of 11 032 hectares.

Every parcel of land mentioned above is shown on the plan prepared by Jean Huberdeau, land surveyor, dated 4 March 1987, bearing no. T 5305-1, under number JH-87-1121 of his minutes.
