## CHAPTER 9

### Appropriation Act No. 3, 1986-87

*[Assented to 27 May 1986]*

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

\$15 575 315  
050.00  
for 1986-87

**1.** The Government may take out of the consolidated revenue fund a sum not exceeding \$15 575 315 050.00 to defray a part of the expenses of Québec proposed in the estimates for the fiscal year 1986-87 as laid before the National Assembly, not otherwise provided for, being the amount of each of the estimates to be voted for various programs set forth in the Schedule, less the amounts voted under the Appropriation Act No. 1, 1986-87 (\$367 784 875.00) and under the Appropriation Act No. 2, 1986-87 (\$5 538 702 775.00).
