## CHAPTER 28

### An Act to amend the Automobile Insurance Act

[Assented to 19 June 1986]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** The Automobile Insurance Act (R.S.Q., chapter A-25) is amended

(1) by replacing the heading of Title V by the following heading:

“FINANCIAL PROVISIONS”;

(2) by inserting, after the heading of Title V, the following:

“CHAPTER I

“FINANCING OF THE RÉGIE”.

**2.** Section 152 of the said Act is amended by replacing the words “of this Act” in the eighth line of the first paragraph by the words and figure “and Chapter II of this title”.

**3.** The said Act is amended by inserting, after section 155, the following:

“CHAPTER II

“PAYMENT INTO CONSOLIDATED REVENUE FUND

**“155.1** The Régie shall pay into the consolidated revenue fund, each year, the sum of \$60 000 000, as reimbursement for the cost of health services required as a result of automobile accidents.

Indexing

From the year 1987, the sum shall be indexed in the manner and at the time provided in section 119 of the Act respecting the Québec Pension Plan (R.S.Q., chapter R-9).

- Instalments** For the year 1986, the sum shall be paid in two equal instalments, the first not later than 4 July and the second not later than 30 September. For subsequent years, the first instalment shall be paid not later than 31 March and the second not later than 30 September each year.
- Revenue of the Government** “**155.2** The sum paid by the Régie not later than 4 July 1986 shall be included in the revenue of the Government for the fiscal year ending 31 March 1986.
- Government order** “**155.3** The Government may, from 1 January 1989 and every three years thereafter, taking account of changes in the cost of health services required as a result of automobile accidents, fix by order a sum different from that contemplated in section 155.1 and the terms and conditions of payment of the sum.
- Draft order** The draft order shall be tabled before the Committee on Planning and Infrastructures. The order may be made at the expiry of thirty days after the tabling of the report of the Committee in the National Assembly.
- Amendment** The Government may amend the draft order and shall, in that case, publish the order in the *Gazette officielle du Québec*.
- Applicability** The second paragraph of section 155.1 does not apply in a year where the Government fixes a sum pursuant to this section.”
- Payment into the consolidated revenue fund** **4.** The Régie de l’assurance automobile du Québec shall pay into the consolidated revenue fund, before 31 March 1987, the sum of \$40 000 000 for the cost of health services required as a result of automobile accidents for the years prior to the year 1986.
- Coming into force** **5.** This Act comes into force on 19 June 1986.
